# Watermain Cleaning and Relining on Dixon Road from Martin Grove Road to west of Kelfield Street

Expected Start Date: Spring 2018
Expected End Date: Fall 2018

\*Timeline is subject to change. Future notice to be provided.

The City of Toronto will be cleaning and structurally relining the watermain in your area in Spring 2018. During this process, the City will also replace the City-owned portion of any substandard water service pipes.

A map of the work area can be found on page 2 of this notice.

The water service is the underground pipe that brings water from the watermain to your water meter and is owned by you <u>and</u> by the City. The part that the City owns goes from the municipal watermain to your property line. The part that you own goes from your property line to your water meter.

This project is part of the Council-approved Capital Works Program to renew Toronto's aging infrastructure, improve water distribution and reduce the risk of watermain breaks.

#### **IMPORTANT INFORMATION ABOUT LEAD WATER SERVICES**

If you live in a property (storefront, office building or house) that was built before the mid-1950s, your water service may be made of lead.

Please read the attached fact sheet with important information about the risks of lead in drinking water, especially if someone in your house is pregnant, there are children under six years old, or there is an infant drinking formula made from tap water.

Please note: Lead pipes were **not** used in apartment buildings or other multi-residential buildings with more than six units.

#### WHAT TO EXPECT BEFORE CONSTRUCTION

- Work crews will mark the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Affected properties will receive a Construction Notice approximately 2-3 weeks before work begins
  with more information about the work, including exact details regarding the project's start and end
  dates.
- Work in the boulevard in front of homes and commercial properties is expected. This work includes removing and replacing a portion of driveways, municipal sidewalks and grassed boulevards, where necessary.
- Property owners should remove items located within City property limits (boulevard), such as landscaping and or decorative objects before work starts.



**Substandard Water Service Replacement:** Please read the attached fact sheet as it contains important information about lead in drinking water and water service replacement. Find out if your water service is lead – a licensed plumber can help you with this. If it is lead, the City of Toronto encourages you to replace it. We recommend you obtain several quotes and you can contact the City's contractor for one of your quotes. Approximately 2-3 weeks prior to construction, you will receive a "Construction Notice" with the name and phone number of the City contractor. Learn more at toronto.ca/lead


