TORONTO LICENSING TRIBUNAL: March 29, 2018 Summary of Decisions K. Cooper / A.N. Alibhai / D. Simon

1. **Harvinder Singh** (Report No. 6963) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B745781)

DECISION:

Vehicle-For-Hire Driver's Licence will be issued to Harvinder Singh, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be suspended until June 20, 2018;
- (3) Vehicle-For-Hire Driver's Licence will be placed on probation for two (2) years from June 20, 2018 to June 20, 2020;
- (4) Prior to each of the next two (2) renewals of the licence, Harvinder Singh must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record and Criminal Record Check;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Harvinder Singh, those matters and report no. 6963, and any updating material, may be brought back before the Tribunal for a full hearing.

2. **Muslimuddin Chowdhury** (Report No. 6174) Holder of Taxicab Driver's Licence No. D01-2016669

DECISION:

The Tribunal approved the following joint Proposed Resolution:

- Effective immediately, the conditions on Mr. Chowdhury's Taxicab Driver's Licence No. D01-2016669, imposed by the Toronto Licensing Tribunal on June 5, 2014, shall be removed.
- Effective immediately, Mr. Chowdhury's Taxicab Driver's Licence No. D01- 2016669 shall be subject to the following conditions:
 - (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
 - (2) Taxicab Driver's Licence No. D01-2016669 will be placed on probation for a period of two (2) years;
 - (3) During the probationary period, Muslimuddin Chowdhury must provide to Municipal Licensing and Standards, at his own expense, his original up-to-date criminal record every six (6) months;
 - (4) During the probationary period, if Muslimuddin Chowdhury incurs any new Criminal Code charges or convictions, he must notify Municipal Licensing and Standards in writing, within five (5) business days;
 - (5) During the probationary period, if Muslimuddin Chowdhury incurs any charges of a sexual nature, his license will be automatically suspended and the matter will be brought back before the Tribunal; and,
 - (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Muslimuddin Chowdhury, those matters and report No. 6174, and any updating material, may be brought back before the Tribunal for a full hearing.

3. Khaza Hossain (Report No. 6967)

Applicant for the Renewal of Toronto Taxicab Owner's Licence No. V00-4426688, Plate No. 4209 AND Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B757001)

DECISION:

Taxicab Owner's Licence No. V00-4426688 will be renewed.

The Tribunal adjourned this matter sine die pending further notification from Municipal Licensing and Standards. The adjournment was granted at the request of Municipal Licensing and Standards in order for MLS to obtain further records. Mr. Khaza Hossain is not permitted to drive a Taxicab.
