TORONTO LICENSING TRIBUNAL: March 8, 2018 Summary of Decisions M. Laverty / A.N. Alibhai / M. Calderwood

1. Tamim Ahmad Amem (Report No. 6931) Applicant for a Tow Truck Driver's Licence (Application No. B730333)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Tow Truck Driver's Licence will be issued, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of five (5) years;
- (3) Prior to each of the next five (5) renewals of the licence, Tamin Ahmad Amem must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record and criminal record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Tamim Ahmad Amem, those matters and report No. 6931, and any updating material, may be brought back before the Tribunal for a full hearing.

2. Piratheepan Tharmakulasingam (Report No. 6950) Applicant for a Tow Truck Driver's Licence (Application No. B734539)

DECISION:

The Tribunal adjourned this matter sine die on consent. This matter will be brought back before the Tribunal following Mr. Tharmakulasingams notification to Municipal Licensing and Standards of the disposition of the criminal proceeding.

3. Pirakas Sivagnanam (Report No. 6773) Applicant for a Tow Truck Driver's Licence (Application No. B685563)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Tow Truck Driver's Licence will be issued to Pirakas Sivagnanam, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of four (4) years;
- (3) Prior to each of the next four (4) renewals of the licence, Pirakas Sivagnanam must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;
- (4) During the probationary period, if Pirakas Sivagnanam incurs any new charges under the Criminal Code, he must notify Municipal Licensing and Standards, in writing within five (5) business days. Pirakas Sivagnanam can notify Municipal Licensing and Standards in one of the following ways:

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

(1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;

- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years;
- (3) Prior to each of the next two (2) renewals of the licence, Kazmain Jaffer Zaidi must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his driving record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Kazmain Jaffer Zaidi, those matters and report No. 6876, and any updating material, may be brought back before the Tribunal for a full hearing.
