INTRODUCTION

This matter relates to an appeal by the City and a neighbour of a decision of the Committee of Adjustment approving minor variances for the construction of a new dwelling. The neighbour is out of the country and brought a motion to adjourn the hearing to be held on April 20, 2018, or in the alternative to participate in the hearing by telephone conference. The motion was heard by telephone conference and the owner /applicant (Mr. Turback), the City Solicitor (Ms. Debacker) and the neighbour (Mr. Klufas) participated in the hearing of the conference.

BACKGROUND

The City and the owner consented to motion requesting that Mr. Klufas participate in the April 20, 2018 hearing by telephone conference. The City pointed out that the owner had not filed a witness statement and, therefore, could not call expert opinion evidence of a planner at the hearing. The owner stated that he was prepared to proceed with the hearing without a planning witness and would only present the plans on file as evidence. He was opposed to any adjournment.
