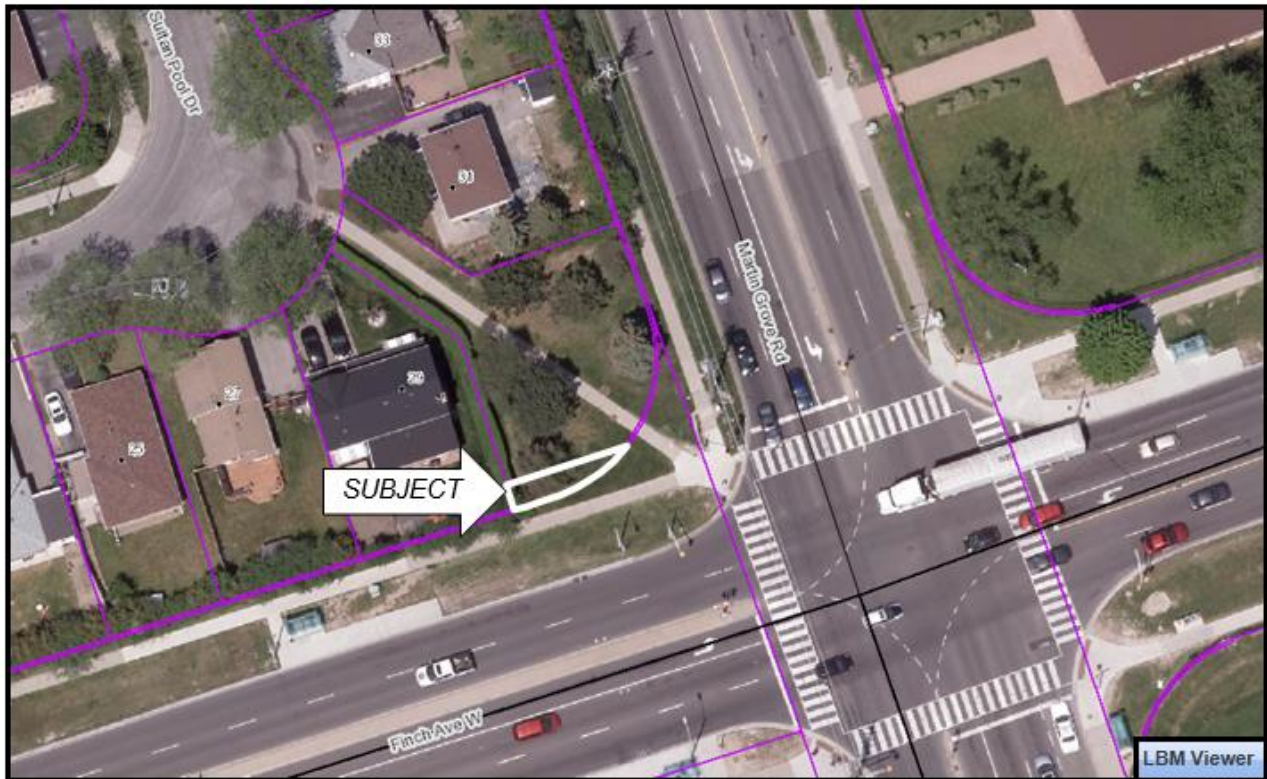
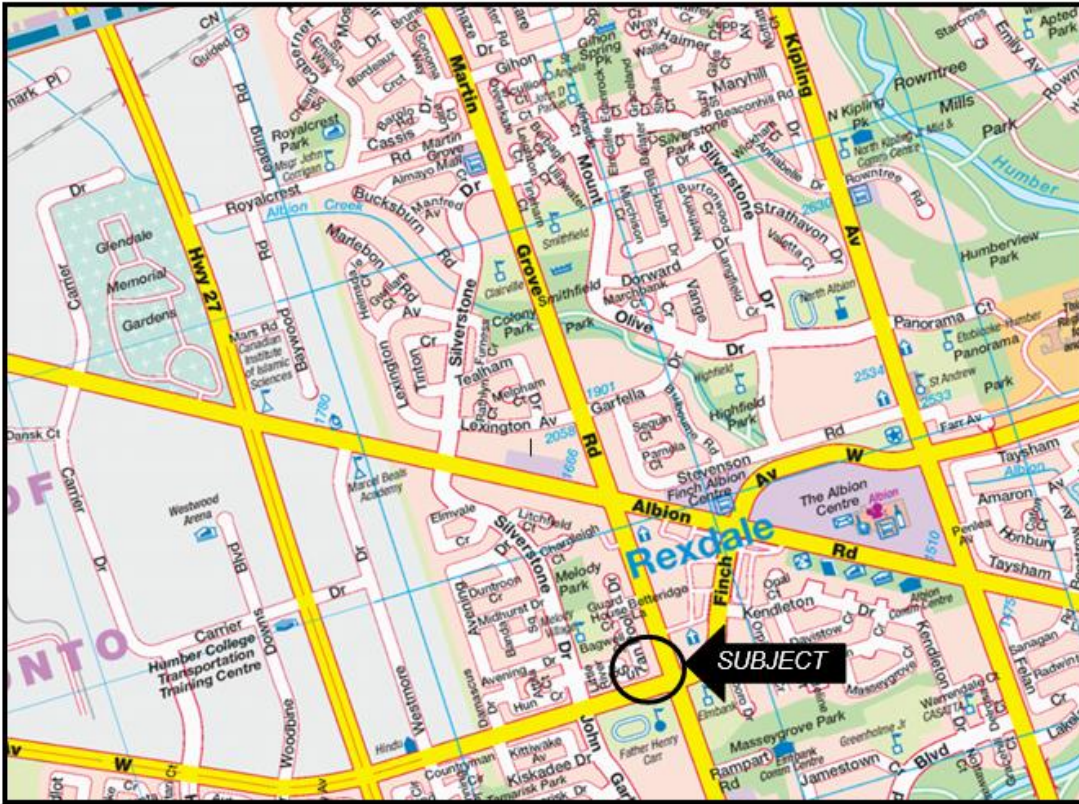
Deputy City Manager, Internal Corporate Services ("DCM, ICS") has approval authority to approve the disposal to Metrolinx of certain Transit Lands for nominal consideration, (on terms satisfactory to the DCM, ICS and in a form acceptable to the City Solicitor).

Purpose	To obtain authority to grant a temporary licence to Metrolinx, for the vacant lands at the northwest corner of Finch Avenue West and Martin Grove Road for road widening and construction work, as required for the implementation of the Finch West Light Rail Transit Project (the "Project").
Property	The City-owned vacant land on the northwest corner of Finch Avenue West and Martin Grove Road, described as Parcel A-1 Sec M1692 Block A on Plan M1692, shown as Part 4 on 66R-29698, (the "Property") in Appendix "A".
Actions	<ol style="list-style-type: none"> 1) Authority be granted to enter into a temporary licence with Metrolinx for a term of five (5) years following thirty (30) days' written notification from Metrolinx, for road widening and construction work, on terms and conditions as set out herein and as deemed appropriate by the DCM, ICS or designate, and in a form satisfactory to the City Solicitor; 2) Authority be granted for the DCM, ICS to administer and manage the temporary licences including the provision of any consent, approvals, waivers, notices and notices of termination provided that the DCM, ICS may, at any time, refer consideration of such matter to City Council for its determination and direction; 3) The appropriate City Officials be authorized and directed to take the necessary action to give effect thereto.
Financial Impact	There is no financial impact resulting from this approval.
Comments	<p>Pursuant to Schedule F (Real Estate Protocol) contained in the Master Agreement between the City, the Toronto Transit Commission and Metrolinx for the implementation of the Toronto Light Rail Transit Program dated November 28, 2012 ("Master Agreement"), temporary use property requirements not required for City purposes are transferred to Metrolinx for nominal consideration. The Acting Chief Financial Officer has reviewed this DAF and agrees with the financial impact information.</p> <p>As part of the Project, Metrolinx has requested for a temporary licence over the Property road widening and construction purposes. The Property Management Committee has reviewed Metrolinx's requirements of the Property and recommends that a temporary licence be granted to Metrolinx.</p>
