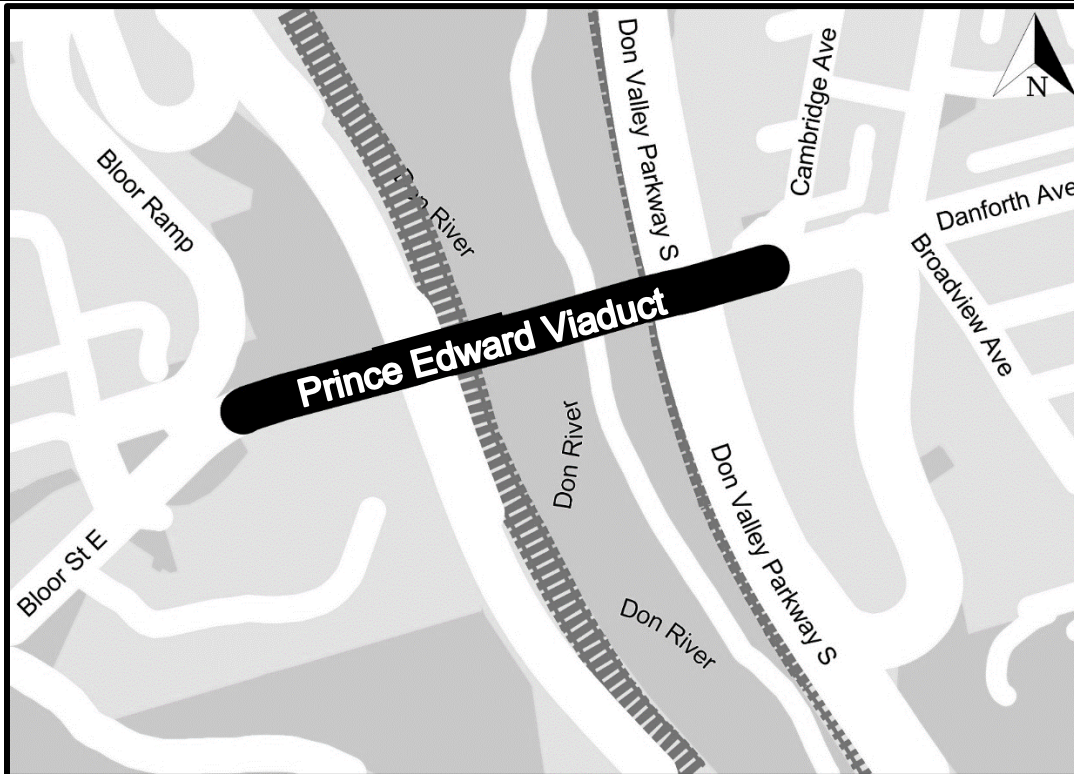
Prince Edward Viaduct Inspection over the Don Valley

Contract: RFP No. 9117-17-5058
Expected Start Date: June 5, 2018
Expected End Date: June 22, 2018

The City of Toronto will inspect the Prince Edward Viaduct over the Don Valley. This work will ensure that the bridge meets today's standards and remains safe for vehicles and pedestrians into the future. The project is part of the Council-approved 2018 Capital Works Program.

These inspections will affect lanes of traffic and sidewalk access. Signage will be posted.

WORK DETAILS

Inspection crews will then:

- Assess the structure's safety barrier for its ability to support inspection workers. Work will be performed at road level using a man-lift.
- Attach temporary accelerometers to the structure and safety barrier to assess its dynamic response. Work will be performed from road level using a man-lift.
- Inspect the barrier system from road level and below road level using rope access techniques. Work will be performed from road level and below deck level.

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience noise and traffic delays due to single lane road closure and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.

	<p>Work Hours: Work will take place from 10:00am to 3:00 pm., Monday to Friday, with work after hours and on weekends as required.</p>
	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the inspection work area.</p> <p>The sidewalk on the side of the structure that is under inspection will be closed during working hours and reopened at 3:00pm daily. Both East and Westbound sidewalks will require temporary closures throughout the inspection project.</p>
	<p>Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers and road users. Road users can expect longer travel times over the Prince Edward Viaduct during work hours.</p> <p>Work will begin on the North side of the bridge.</p> <p>In order to complete this work, the existing westbound cycle lane and a portion of the traffic lane will be used. One lane of Westbound traffic and a cycle lane separated by barrels will be provided during work hours.</p> <p>When inspections move to the south side of the bridge, the same staging will be provided for eastbound traffic.</p>
