

The Eglinton Crosstown Light Rail Transit (LRT) is being constructed along Eglinton Avenue, from Weston Road to Kennedy Road. When the LRT opens in 2021, it will pass through the Golden Mile area. There will be five surface LRT stops between Victoria Park Avenue and Birchmount Road.

The City of Toronto Planning Division is undertaking a **Golden Mile Secondary Plan Study** in advance of the opening of the Eglinton Crosstown LRT. The intent of this Study is to develop a vision and planning framework to guide future development of the Golden Mile area. The Study area includes lands north and south of Eglinton Avenue East, between Victoria Park Avenue and Birchmount Road. The Study is expected to be completed in early 2019.

Join us at the **Community Consultation Meeting** to participate in Phase 2 of the Study, which will include:

- an update on the status of the Study;
- the emerging street and block network;
- three potential development alternatives (including open space, land uses and built form);
- opportunities for local residents, employees, businesses and landowners to provide feedback; and
- next steps for the Study.
