- A drawing in a metric scale showing:
 - banner sign and/or temporary decorations, including text and any symbols/pictures
 - names and identifying symbols of the sponsor(s), corporate recognition must not exceed 20% of the total surface area of each side of the banner
 - exact description of any wire cable or brackets and other supports and fastening devices
 - type of fabric of which the banner will be made and method and means of installing, securing and removing the banner/temporary decorations
- Evidence of \$2 million liability insurance with the City identified as an additional insured, or as required by the City
- A non-refundable application fee

Upon approval of your application, it will be necessary to:

- Pay a permit fee and any additional fee, if applicable. Payment can be made by Visa, American Express, MasterCard, Interac/Debit, or cheque, payable to the Treasurer, City of Toronto.
