# TORONTO LICENSING TRIBUNAL: May 3, 2018 Summary of Decisions K. Cooper / A.N. Alibhai / D. Simon

**1. Irsalan Shakir Riaz** (Report No. 6927) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B730328)

#### **DECISION:**

The Tribunal approved the following joint Proposed Resolution:

Vehicle-for-Hire Driver's Licence will be issued to Irsalan Shakir Riaz, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-for-Hire Driver's Licence will be placed on probation for a period of two (2) years;

**9. Rajeeban Nandakumar** (Report No. 6976) Applicant for a Tow Truck Driver's Licence (Application No. B754022)

### **DECISION:**

The Tribunal approved the following joint Proposed Resolution:

Tow Truck Driver's Licence will be issued, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of four (4) years;
- (3) Prior to the next four (4) renewals of the licence, Rajeeban Nandakumar must provide to Municipal Licensing and Standards, at this own expense, an original up-to-date abstract of his driving record;
- (4) During the probationary period, if Rajeeban Nandakumar is charged with any alcohol-related driving offence or if his provincial driver's licence is suspended for any alcohol-related occurrence, he must notify Municipal Licensing and Standards within three (3) business days from the date of the charge or occurrence. Mr Nandakumar can notify Municipal licensing and standards in one of the follow ways:

- (5) During the probationary period, if Rajeeban Nandakumar is charged with any alcohol-related driving offence or if his provincial driver's licence is suspended for any alcohol-related occurrence, his Tow Truck Driver's Licence will be suspended forthwith, and Municipal Licensing and Standards, at the earliest opportunity after the investigation into the matter is completed, will bring the report No. 6976 and any new information before the Tribunal for a full hearing;
- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any other new charges or convictions against Rajeeban Nandakumar, those matters and report no. 6976, and any updating material, may be brought back before the Tribunal for a full hearing.
