#### **Council Direction**

Due to significant development applications within the area and in accordance with Official Plan policy 2.3.1.3, Council directed City staff to undertake an "area-based character study of the High Park Apartment Neighbourhood" and report back by the 2nd Quarter of 2018 (EY21.4 and EY21.5).



# Toronto Official Plan HEALTHY NEIGHBOURHOODS policy 2.3.1.3

"Where significant intensification of land adjacent to a Neighbourhood or Apartment Neighbourhood is proposed, Council will determine, at the earliest point in the process, whether or not a Secondary Plan, area specific zoning by-law or area specific policy will be created in consultation with the local community following an Avenue Study, or area based study."





#### **Study Area**

- 19.6 hectares
- 21 properties, lands designated Apartment Neighbourhoods or Parks and Open Space Areas
- 7 public streets, 51 buildings (2 under construction), 2 public parks and High Park TTC station
- Properties south of study area evaluated in Bloor West Village Avenue Study and Heritage Conservation District Study.





### **Study Purpose**

- Evaluate existing area characteristics
- Identify appropriate policies, principles and guidelines that will guide change and compatible infill development in the study area.







### **Study Outcomes**


- Natural Heritage Impact Study Addendum (May 2018)
- Area Character Study (May 2018)
- Draft Official Plan Amendment 419 & Site and Area Specific Policy 551
- Area Specific Urban Design Guidelines (mid-June 2018 Community Consultation)
- Biodiverse Landscape Manual for the High Park Area (2019)





#### Natural Heritage Impact Study

- The study area is located north of High Park and is in close proximity to lands identified as Provincial Area of Natural and Scientific Interest (ANSI), Environmentally Significant Area (ESA), natural heritage system, ravines and natural features.
- High Park is recognized as a significant stopover for migratory birds, and the mature tree canopy and structures in the study area are possible habitat for species of conservation concern.
- An addendum to the Bloor West Village Avenue Natural Heritage Impact Study (March 2018) was prepared for the study area and informs the draft Official Plan Amendment.







#### Social Pinpoint December 15, 2017 to January 23, 2018

#### **Draft Official Plan Amendment 419**

 Developed from Area Character Study findings and community consultation

#### Key components:

- Adds views to Map 7a and Schedule 4
- Redesignates 21 High Park from Apartment Neighbourhoods to Parks and Open Space Areas – Parks
- Includes **Site and Area Specific Policy No. 551** to guide change and compatible infill development within the study area.






#### **Report Recommendations:**
