Road Resurfacing on Martin Grove Road from Lavington Drive to Eglinton Avenue West and on The Westway from Martin Grove Road to Royal York Road


Contract: 18ECS-TI-13MR Start Date: July 2018 End Date: October 2018 *Timeline is subject to change.

The City of Toronto will resurface the road on Martin Grove Road from Lavington Drive to 50 metre south of Eglinton Avenue West and The Westway from Martin Grove Road to Royal York Road. The City will not resurface the intersection of Kipling Avenue and The Westway because it was resurfaced recently. Our inspection of the road shows that it needs repaving and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair.

This work on The Westway also involves widening some sidewalks and upgrading some TTC bus stops. Crews will make pedestrian improvements at the Eglinton Avenue West & Martin Grove Road intersection.

This work is part of the Council-approved 2018 Capital Works Program to renew aging city roads and sidewalk for current and future needs.

WORK DETAILS

In the first few weeks, the City's contractor will move equipment on-site and prepare the work area before construction begins. Construction crews will then:

- Dig up the road surface
- Re-align maintenance holes and catch basins
- Repair curbs, gutters and driveways
- · Repave the road surface

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- Property owners should remove items located within City property limits (boulevard), such as landscaping and/or decorative objects. If you have a sprinkler system within the boulevard, please contact the Project Manager.
- The City will not be responsible for damage to any privately owned items on City property.



Work Hours: Work on **The Westway** will take place from 7:00 am to 7:00 pm., Monday to Friday and 7:00 a.m. to 7:00 p.m. on Saturdays.

Work on **Martin Grove Road** will use extended hours to minimize traffic disruption and to shorten the project duration. Work will take place from 7:00 a.m. to 11:00 p.m., Monday to Friday; 7:00 a.m. to 9:00 p.m. Saturday and Sunday.

When working at the intersection of Martin Grove Road and Eglinton Avenue West, the contractor will work overnight for 24 hours on selected weekends.



Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.

Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.



Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Some of these efforts include adding Local Access signs, revising traffic signal times. Road users should expect delays and increased traffic on nearby main and side streets.

Traffic on The Martin Grove Road and The Westway will be reduced to one lane in each direction in the vicinity of the work.



Parking: Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at **416-808-2222**.

In the event you receive a traffic ticket for on-street parking during this period of construction, you may choose to dispute your ticket following the process listed on the reverse side of the parking infraction notice. You may use this notice as part of your defence for parking consideration during construction; however, the Project Manager does not have the authority to cancel any parking tickets.



Garbage & Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. *Please ensure that you label your bins with your address.*



Restoration: The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).
