EMERGENCY WORK
Sanitary Sewer
G. Ross Lord Park

Start Date: May 7, 2018

Expected Completion Date: September 30, 2018

Emergency repairs are required for a sanitary sewer located under G. Ross Lord Park stormwater reservoir. In addition to this emergency work, underway is a larger longer-term capital project that includes decommissioning two sanitary sewers located under the G. Ross Lord Park stormwater reservoir and constructing new sanitary sewers. The City of Toronto is working closely with the Toronto and Region Conservation Authority on all work in this area.

The expected completion date has been extended from June 30 to September 30 to allow time for a City contractor to construct a new sewer that will be connected to existing sanitary sewers. In the meantime, a below ground sewer bypass pipe will be installed by the City. Please see more information under Work Details below.



WORK DETAILS

- This emergency work includes (please see map on reverse side for details):
- Installation of two above ground sewer bypasses and decommissioning of one sanitary sewer located under the G. Ross Lord Dam (stormwater control dam). This phase has been installed and is currently operating.
 - The bypasses will not impact wastewater discharge to any local sewers.
 - Both bypass areas are enclosed with fencing and will be monitored.
 - Enhancing the above ground sewer bypasses with the installation of a below ground sewer bypass pipe. The below ground sewer bypass pipe will be in place until the permanent connection is completed.
 - Constructing a new sewer to connect between to existing sanitary sewers. This phase will start mid-July and is expected to be complete by September 30, 2018.
 - Heavy construction equipment and staff will be onsite while the work is underway.
 - Work station #1 and #2 are the main construction area for the two bypasses; work station #3 is the back-up area where additional equipment staging may be required while the work is underway.

PARK ACCESS

- Disruption to park users will be minimal with no closures to any of the park's paved roads. There may at times be temporary restrictions to pedestrian access when heavy equipment is being moved into work station areas.

WHAT TO EXPECT DURING CONSTRUCTION

	Work Hours: As a result of the emergency work, construction will occur 24 hours a day, 7 days a week. It is expected to be completed on September 30.
	Pedestrian Access: To complete the work safely, some pedestrian restrictions may occur. Temporary fencing and signs have been set up in and around the construction site.
