- (4) If Municipal Licensing and Standards has concerns with any charges or convictions against 2620691 Ontario Ltd or Derek Anthony Salick, or any other concerns with respect to the conduct of the licensee and/or its agents or employees, those matters, this Report, and any updating material, may be brought back before the Tribunal for a full hearing.
