2. Estate of Leo Awin (Report No. 7038)

Applicant for the Renewal of Toronto Taxicab Owner's Licence AND

Applicant for a Vehicle-For-Hire Driver's Licence

DECISIONS ON INTERIM MOTIONS:

The Tribunal issued an order for this matter to proceed in camera, on consent. Mr. Robert Stewart, Paralegal for K. H., brought a motion for adjournment and a motion to have a Pre-Hearing under Rule 15 of the Tribunal's Rules of Procedure. The motion for adjournment was moot as the matter was not discussed until late in the day. 4. Baldev Singh Sidhu (Report No. 7033)

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B821743)

DECISION:

Vehicle-For-Hire Driver's Licence will be issued to Baldev Singh Sidhu, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application will be cancelled:
- (2) Immediately upon being issued, the licence will be placed on probation for a period of three (3) years;
- (3) Prior to each of the next three (3) renewals of the licence, Mr. Sidhu must provide to Municipal Licensing and Standards, at his own expense, an original updated abstract of his driving record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Sidhu, those matters and report No. 7033, and any updating material, may be brought back before the Tribunal for a full hearing.
- (5) During the probationary period, if Mr. Sidhu is charged with any alcohol related driving offence, or if his Provincial Driver's Licence is suspended for any alcohol related reason, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. Mr. Sidhu can notify Municipal Licensing and Standards in one of the following ways:
