TORONTO LICENSING TRIBUNAL: August 23, 2018 Summary of Decisions M. Laverty / A. Bakshi / M. Calderwood

Estate of Edwin Dawidowitz (Report No. 7063) Larry Edwin Dawidowitz, Estate Trustee Holder of Taxicab Owner's Licence No. V02-4744965, Taxicab Plate No. 3429

DECISION:

The Tribunal extended Taxicab Owner's Licence No. V02-4744965 for Taxicab Plate No. 3429 to remain in the Estate of Larry Edwin Dawidowitz for one year (from July 1, 2018 to July 1, 2019).

2. Mesfin Negussie (Report No. 7032)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4710734

DECISION:

The Tribunal approved the joint Proposed Resolution:

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of four (4) years. The Applicant is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the Applicant and conduct other investigations, as appropriate, to assess the Applicant's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mesfin Negussie or any other concerns with respect to the conduct of the licensee, those matters and report no. 7032, and any updating material, may be brought back before the Tribunal for a full hearing.
- **3. John Douglas Riley** (Report No. 7037) Applicant for a Tow Truck Driver's Licence (Application No. B823475)

DECISION:

The Tribunal approved the verbal Proposed Resolution:

John Douglas Riley's licence will be issued, effective immediately, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, (excluding outstanding provincial offence fines) failing which the application may be cancelled;
- (2) Immediately upon being issued, the Tow Truck Driver's licence will be placed on probation for a period of five (5) years. Mr. Riley is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Riley and conduct other investigations, as appropriate, to assess the Applicant's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Mr. Riley must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record every six
 (6) months for the next 5 years;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 7037, and any updating material, may be brought back before the Tribunal for a full hearing.

DECISION:

The Tribunal extended Taxicab Owner's Licence Nos. V02-4829403 and V02-4829401 for Taxicab Plate Nos. 3141 and 1318 to remain in the Estate of Evelyn Mabel Floras for six months (from July 23, 2018 to January 23, 2019).

6. Aurangzeb Zaffar Khan (Report No. 6997) Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-3842265

DECISION:

The Tribunal approved the following Proposed Resolution:

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Vehicle-For-Hire Driver's Licence will be renewed and suspended for two (2) days; Mr. Khan must surrender his licence and photo card to Municipal Licensing and Standards on the first day of the suspension. The suspension will take place between 9:00 a.m. August 27, 2018 to 9:00 a.m. August 29, 2018;

- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. The Applicant is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the Applicant and conduct other investigations, as appropriate, to assess the Applicant's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Aurangzeb Zaffar Khan or any other concerns with respect to the conduct of the licensee, those matters and report no. 6997, and any updating material, may be brought back before the Tribunal for a full hearing.

 7. Bikini in Manila Ltd. (Report No. 7018) o/a Bikini in Manila Lito Tugade Closa, Director Dante S. Calma, Director Applicant for the Renewal of Eating Establishment Licence No. B71-4723972
