TORONTO LICENSING TRIBUNAL: August 9, 2018 Summary of Decisions M. Laverty / K. Cooper / V. Romero

1. Krishnaparan Kandiah (Report No. 6854) Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-2016335

DECISION:

Report No. 6854 was withdrawn by Municipal Licensing and Standards and the licence will be cancelled. (Mr. Kandiah is no longer pursuing the Renewal of his Vehicle-For-Hire Driver's Licence and has requested the cancellation of the licence).

2. Andrew John McDonald (Report No. 6908) Applicant for a Tow Truck Driver's Licence (Application No. B724158)

DECISION:

The Tribunal declared Andrew John McDonald's application for a Tow Truck Driver's Licence as abandoned.

(Mr. McDonald failed to attend today's hearing)

3. Jamaluddin Nabizada (Report No. 7029) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B825057)

DECISION:

The Tribunal approved the joint Proposed Resolution:

A Vehicle-For-Hire Driver's Licence will be issued to Applicant, subject to the following conditions:

 All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;

- (2) Vehicle-For-Hire Driver's Licence will be issued and immediately suspended for four (4) days;
- (3) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. The Applicant is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the Applicant and conduct other investigations as appropriate, to assess the Applicant's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) Prior to each of the next three (3) renewals of the licence, the Applicant must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against the Applicant or any other concerns with respect to the conduct of the licensee, those matters and report no. 7029 and any updating material, may be brought back before the Tribunal for a full hearing.

4. Estate of Jonathan Corion (Report No. 7061)

Shael Bryan Eisen, Estate Trustee Holder of Taxicab Owner's Licence No. V02-4712906, Taxicab Plate No. A256

DECISION:

The Tribunal extended Taxicab Owner's Licence No. V02-4712906 for Taxicab Plate No. A256 to remain in the Estate of Jonathan Corion for sixty days (from August 9, 2018 until October 9, 2018).

DECISION:

DECISION:

Eating Establishment Licence No. B71-4420978 is cancelled as of July 17, 2018, therefore Report No. 7042 was withdrawn by Municipal Licensing and Standards. (Mr. Ahmadi requested the cancellation of the licence).

(Mr. Ahmadi did not attend today's hearing).

7. Abid Chaudry (Report No. 7010)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-3730653

DECISION:

The Tribunal approved the joint Proposed Resolution

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) Vehicle-For-Hire Driver's Licence will be renewed and suspended for

five (5) days commencing on Monday August 13, 2018; Mr. Chaudry must surrender his licence and photo card to Municipal Licensing and Standards on the first day of the suspension;

- (3) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. The Applicant is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the Applicant and conduct other investigations, as appropriate, to assess the Applicant's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) Prior to each of the next three (3) renewals of the licence, Abid Chaudry must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against the Applicant or any other concerns with respect to the conduct of the licensee, those matters and report no. 7010 and any updating material, may be brought back before the Tribunal for a full hearing.
