## TORONTO LICENSING TRIBUNAL: July 26, 2018 Summary of Decisions M. Laverty / K. Cooper / D. Simon

1. Wahid Ahmad Kabir (Report No. 7031) Holder of Vehicle-For-Hire Driver's Licence No. D01-4656840

## **DECISION:**

The Tribunal approved the following Interim Proposed Resolution, subject to the following conditions: Condition 1 and 3 have been amended to the Interim Proposed Resolution dated July 16, 2018.

- The Tribunal proceeding in this matter shall be adjourned sine die, pending the disposition of the criminal charge, or sooner if either party so requests;
- (2) The Vehicle-For-Hire Driver's Licence shall be suspended until further order of the Tribunal:

2. Angellos Malamas (Report No. 6954)

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B734700)

## **DECISION:**

Vehicle-For-Hire Driver's Licence will be issued to Angellos Malamas, subject to the following conditions:

- Mr. Malamas must pay all outstanding bylaw fines by November 26, 2018 prior to the licence being issued, failing which the licence will be cancelled/revoked;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Malamas under any acts including Toronto Municipal Code and any concerns with Mr. Malamas' conduct towards Municipal Licensing and Standards staff, those matters and report No. 6954, and any updating material, may be brought back before the Tribunal for a full hearing.
