Division: Prepared By: Van Hua Real Estate Services Date Prepared: August 24, 2018 Phone No.: 416 338 9572 **Purpose** To obtain authority to enter into a five (5) year Licence Extension and Amending Agreement with The Leo Baeck Day School (the "Licensee") for use of a portion of a City owned parking lot and park lands in Cedarvale Park (the "Property") for the purpose of parking, playground and sports court. Cedarvale Park in Ward 21, being part of PIN 10464-0294 (LT). See Appendix "A". **Property** Actions The City enter into a Licence Extension and Amending Agreement with the Licensee on the terms and conditions set out herein and such other terms and conditions satisfactory to the Director, Real Estate Services or designate, and in a form satisfactory to the City Solicitor. The appropriate City Officials be authorized and directed to take the necessary action to give effect thereto. The City Solicitor be authorized to complete the transaction on behalf of the City, including paying any necessary expenses, amending the closing, due diligence and other dates, and amending and waiving terms and conditions on such terms as he/she considers reasonable. **Financial Impact** The City will receive revenue over the term of five (5) years of \$162,626.26 (plus HST). The annual revenue is detailed as follows: 1) \$12,500.00 (plus HST) in 2017; \$31,500.00 (plus HST) in 2018; 3) \$32,130.00 (plus HST) in 2019; 4) \$32,772.60 (plus HST) in 2020; 5) \$33,428.05 (plus HST) in 2021; and \$20,295.60 (plus HST) in 2022. The fee escalates 2% annually. Annual revenue will be incorporated into the 2018 Council Approved Operating Budget and future budget submissions for Parks, Forestry & Recreation under cost center FA1379. The Interim Chief Financial Officer has reviewed this DAF and agrees with the financial impact information. Comments The Leo Baeck Day School is located at 501 Arlington Ave. DAF 2012-226 and 2013-144 authorized the Licensee and the City of Toronto (the "City) to enter into a five (5) year Licence Agreement (the "Agreement") dated September 1, 2012, with a Commencement Date of September 1, 2012. The term runs from September 1st through June 30th of each year. Per section 3(2) of the Agreement, the Licensee has the option to renew/extend for a further term of five (5) years. The Licensee no longer requires the use of a drop off zone, therefore the Licensed Premises will be reduced by approximately 4,800 square feet. **Terms** The terms and conditions remain the same as in the Agreement except for the Licence Fee and the Licensed Premises. 

General Conditions ("GC")

- (a) The local Councillor (or local Councillors if the subject property is located on a ward boundary or if the transaction involves an exchange of properties in more than one ward), will be consulted prior to the exercise of delegated Approving Authority by staff for all Acquisitions, Disposals, Land Exchanges and Leases. In the event of a vacancy in the Ward in which the subject property is located, the Mayor's office shall be consulted in the alternative.
- (b) Where approving power has been delegated to staff, the Deputy City Manager, Internal Corporate Services, in consultation with any other applicable Deputy City Manager or the City Manager, may determine that such matter is of such special interest that same should be returned to the relevant Committee and Council for consideration and determination.
- (c) Exercise of delegated authority is subject to all applicable Council policies, statutes or other applicable law.
- (d) Authority to approve financial commitments/expenditures is subject to all amounts being available in an approved budget, or funding being available from third party sources, except for "Strategic Property Acquisitions" as set out in EX44.22 adopted by Council August 25, 26, 27 and 28, 2014, which identifies alternative funding mechanisms subject to additional approval requirements.
- (e) Property interests are to be based on appraised value, and no interest shall be granted at less than market value unless otherwise specifically authorized.
- (f) Authority to approve transactions at less than market value is subject to statutory anti-bonusing provisions.
- (g) Total compensation means the aggregate of all types of payments, including land value, estimated clean-up costs, potential arbitration awards, loss claims, etc., but exclusive of any applicable taxes and registration costs.
- (h) Authority to acquire property is conditional upon provision being made to bring the property into compliance with applicable MOE or other requirements such that it will be fit for its intended municipal purpose, except for property acquisitions of 50M² or less for transit shelter purposes.
- (i) Authority to initiate the permanent road closure process in A.4 is conditional upon confirmation by the GM of Transportation Services that it is feasible to permanently close the highway.
- (j) Disposal authorities in A.7 are subject to the property having been declared surplus, and the disposal policy complied with.
- (k) Land exchanges, except for those in A.8, may be authorized based on the delegated Approving Authority for disposals in A.7.
- (I) Approving Authority with respect to land located in the Designated Waterfront Area as defined in the *Toronto Waterfront Revitalization Corporation Act*, 2002 is conditional upon the approval of the Director, Waterfront Secretariat.
- (m) Authority to approve an exchange of land in A.8 is conditional upon confirmation by the Chief Planner and Executive Director of City Planning, and the GM of Parks, Forestry & Recreation, that the land being exchanged is (i) nearby land of equivalent or larger area, and (ii) of comparable or superior green space utility.
- (n) Approving Authority in A.9 Leases (City as Landlord) but not Licences (City as Licensor) is limited to periods (including options/renewals) of less than twenty-one (21) years, as leases of 21 years or more may be authorized based on the delegated Approving Authority for disposals in A.7.
- (o) Total compensation in leasing matters where the City is landlord (A.9) includes the value of tenant improvements if factored into tenant's rental payments.
- (p) Total compensation in leasing matters where the City is the tenant (A.10) includes the value of any tenant improvements to be paid by the City.
- (q) Where options/renewals are included in leases, if the renewal rent is to be determined at a date later than the original approval date, total compensation is to be calculated as though all options are exercised, estimating the renewal rent based on the highest rent payable in the first term of the lease.
- (r) Total compensation in leasing matters where the City is landlord (A.9) or tenant (A.10) is to be calculated from the date of approval pursuant to this delegation (ie. first allowing for the expiry of any prior approvals, whether by Council or a delegated authority).
- (s) Approving Authority in leasing matters includes authority to approve renewals/extensions within the parameters of the delegated Approving Authority.
- (t) Approving Authority includes authority for amendments within the parameters of the delegated Approving Authority, the cumulative total of which may not exceed the delegated financial limit.
- (u) Where proposed additional amounts in A.13 exceed 10 per cent of the original decision, even if otherwise in compliance with all other conditions, then Approving Authority is transferred upwards to the next more senior level of Approving Authority having the relevant overall financial limit.
- (v) Approving Authority includes authority for all documents necessary to implement the authority, including ancillary agreements, on terms and conditions satisfactory to the Approving Authority, in consultation with the relevant operating Division(s).
- (w) Staff positions referred to in this delegation include successors from time to time.
- (x) Documents are to be in a form satisfactory to the City Solicitor (including indemnity and insurance provisions).
- (y) Delegated signing authorities in **B** are conditional upon the documents having received the City Solicitor's prior "Approval as to Form".
- (2) Authority to use land acquired by the City for parking purposes by the Toronto Parking Authority is conditional upon Council enacting a by-law designating such use.
- (aa) All residential leasing documents shall adhere to the Residential Tenancies Act, 2006 and any successor legislation.
- (bb) Despite GC(n), Approving Authority in residential leasing matters is not limited to periods of less than twenty-one (21) years and total compensation in residential leasing matters where the City is landlord is to be calculated based on an assumed term of ten years unless the lease term expressly identified therein is longer.
- (cc) Where Approving Authority has been delegated to the Manager level, such authority shall be conditional upon the Manager first having secured the written concurrence of a second Manager within the Real Estate Services Division.
- (dd) Where the City is transacting with a public agency, and such agency requires that an unqualified environmental indemnity be granted by the City, the authority to acquire property includes authority to grant such an indemnity, provided that the Phase I and Phase II environmental site assessments undertaken on behalf of the City have identified no significant environmental impacts or human health threats, with no, or minor action required ("Low Risk").

Appendix "B"Major Terms and Conditions

Licensor: City of Toronto

Licensee: The Leo Baeck Day School

Term: Five (5) years, commencing September 1, 2017 and ending on June 30, 2022 during a certain period

of each year, being Monday to Friday from 7am to 5pm from September 1st to June 30th (the "School Use Period"). The City shall have the right to allow public use of the Licensed Premises outside the

School Use Period.

Licenced Premises: Approximately 18,944 square feet in total as identified in Appendix "A".

Area A (29 parking spots) and B (25 parking spots) total of 54 parking spots, approximately 11,504

square feet.

Area C and D is a playground and sports court, approximately 7,440 square feet.

Licence Fee: The Licence fee escalates at 2% annually. The Licensee shall pay to the City an annual Licence Fee

payable in equal monthly instalments as follows:
