# TORONTO LICENSING TRIBUNAL: October 11, 2018 Summary of Decisions M. Calderwood / A. Bakshi / M. Laverty

## 1. Kevin Singh (Report No. 7054)

Applicant for a Tow Truck Driver's Licence (Application No. B835113)

#### **DECISION:**

The Tribunal approved the following joint Proposed Resolution:

Tow Truck Driver's License will be issued to Kevin Singh, subject to the following conditions:

- (1) Within 30 days of the Tribunal hearing, Mr. Singh must pay all overdue bylaw fines and submit all fees, documents and/or any outstanding requirements to the satisfaction of Municipal Licensing and Standards, failing which the application may be cancelled;
- (2) Immediately upon being issued, Tow Truck Driver's license will be placed on a probation for a period of five (5) years. The Applicant is advised that during the probationary period, MLS may make additional checks of any driving criminal and by-law charges and convictions against the Applicant and conduct other investigations, as appropriate, to assess the Applicant's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next five (5) renewals of the licence, Mr. Singh must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Kevin Singh or any other concerns with respect to the conduct of the licensee, those matters and report no. 7054, and any updating material, may be brought back before the Tribunal for a full hearing.

 Bikini in Manila Ltd. (Report No. 7018) o/a Bikini in Manila Lito Tugade Closa, Director Dante S. Calma, Director Applicant for the Renewal of Eating Establishment Licence No. B71-4723972

### **DECISION:**

The Tribunal approved the following joint Proposed Resolution:

Eating Establishment Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) Immediately upon being renewed, Eating Establishment Licence will be placed on probation for a period of two (2) years;
- (3) Prior to each of the next two (2) renewals of the licence, Lito Tugade Closa must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Lito Tugade Closa or Dante S Calma or Bikini in Manila Ltd. or any other concerns with respect to the conduct of the licensee, those matters and report no. 7018, and any updating material, may be brought back before the Tribunal for a full hearing.
- **3. Piratheepan Tharmakulasingam** (Report No. 6950) Applicant for a Tow Truck Driver's Licence (Application No. B734539)

#### **DECISION:**

The Tribunal adjourned this matter to November 15, 2018; Mr. Tharmakulasingam advised Tribunal Staff over the phone that he is withdrawing his application for a Tow Truck Drivers Licence. Mr. Tharmakulasingam was asked to confirm this information in writing. Tribunal Staff are to notify Municipal Licensing and Standards once the written confirmation is received. If not received, this matter will be addressed on record on November 15, 2018.
