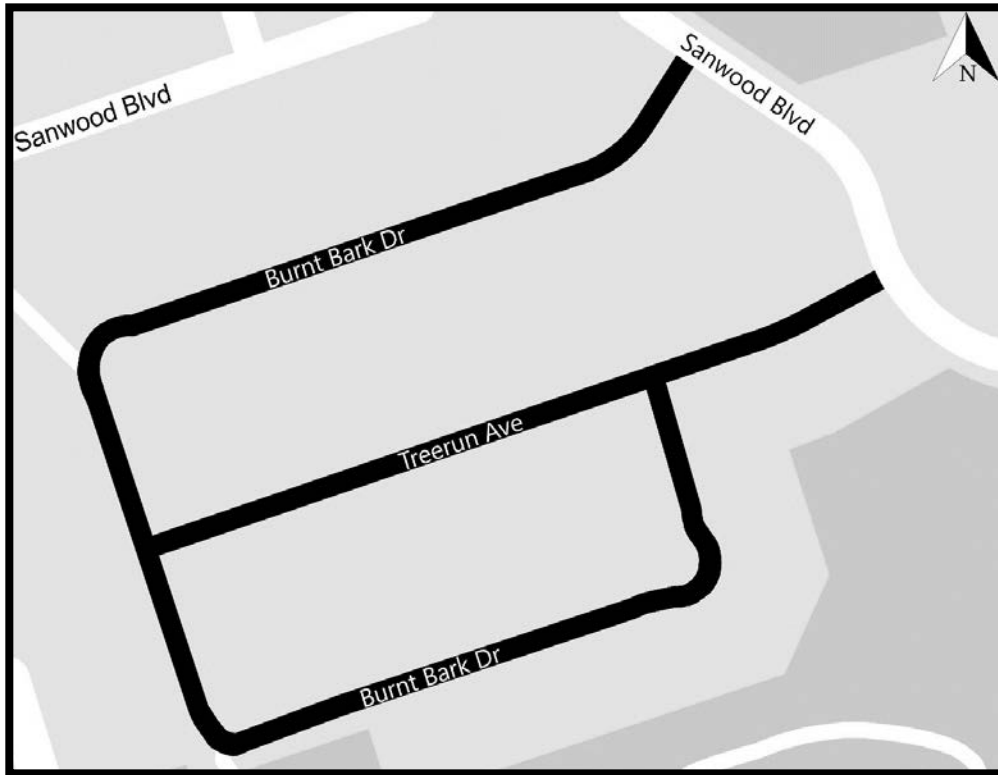
Road Resurfacing on Burnt Bark Drive and Treerun Avenue

Contract: 18ECS-TI-15LR
Start Date: October 29, 2018
End Date: December 07, 2018
**Timeline is subject to change.*

The City of Toronto will resurface the road on Burnt Bark Drive and Treerun Avenue (see map). Our inspection of the road shows that it needs resurfacing and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair. This work is part of the Council-approved 2018 Capital Works Program to renew aging city roads and sidewalk for current and future needs.

WORK DETAILS









- The City's contractor will:
- Dig up the road surface
 - Re-align maintenance holes and catch basins
 - Repair curbs, gutters and driveways
 - Repave the road surface

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- Property owners should remove items located within City property limits (boulevard), such as landscaping and/or decorative objects. If you have a sprinkler system within the boulevard, please contact the Field Ambassador.
- The City will not be responsible for damage to any privately owned items on City property.

WHAT TO EXPECT DURING CONSTRUCTION

	<p>Work Hours: Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.</p>
	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.</p>
	<p>Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents.</p> <p>Traffic will be reduced on streets with active construction/access may be limited when paving operations are taking place.</p>
	<p>Parking: Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at 416-808-2222.</p> <p>In the event you receive a traffic ticket for on-street parking during this period of construction, you may choose to dispute your ticket following the process listed on the reverse side of the parking infraction notice. You may use this notice as part of your defence for parking consideration during construction; however, the Project Manager does not have the authority to cancel any parking tickets.</p>
	<p>Garbage & Recycling: Please follow your normal routine. If required, the contractor will move bins to an appropriate location and return them. Please ensure that you label your bins with your address.</p>
	<p>Restoration: The construction work area will be restored with sod and/or asphalt where required. Interlocking bricks, flagstone on a granular base, or other similar features that are removed from public and private property during construction will be replaced. Lawn seeding and/or laying of sod will be done as needed during ideal growing seasons only - in the spring (April to June) and fall (September to October).</p>

多伦多市政府将重新铺设伯恩特巴克路 (Burnt Bark Drive) 和特利朗大道 (Treerun Avenue) 的路面 (见地图)。我们对上述路段检查后发现, 为了维持道路的良好状态, 路面需要重铺, 部分损坏的路缘和人行道需要更换。这项工作是市议会批准的2018年基建工程计划中的一部分, 旨在更新老化的城市道路和人行道以满足当前及未来的需求。







施工详情

市政府承包商将:

- 挖掘路面
- 重新调整检修孔和路边集水池
- 修复路缘、沟槽及车道
- 重铺路面

施工期间预期会怎样

- 您可能会遇到粉尘、噪音和其他不便。市政府将努力减少这些不利影响。我们感谢您的耐心。
- 业主应移除市政府产权界限 (道路) 内的物品, 如景观和/或装饰品。如果您在道路范围内安装了洒水系统, 请联系现场协调员 (Field Ambassador)。
- 市政府对发生在市府产权界限内的私有物品损坏概不负责。

	工作时间: 工作时间为早 7:00 至晚 7:00, 周一至周五, 必要时也会加班或在周末工作。
	道路和人行道的使用: 为了施工安全, 将限制使用施工区内的道路和人行道, 但应急车辆可随时通行。 私人车道的使用: 如果需要临时限制您的私人车道使用, 承包商将发出通知。如果您的物业有两个入口, 其中一个入口将始终保持开放。
	交通管理: 为了工人、道路使用者和居民的安全, 我们将尽力管控好该地区的交通。 正在施工的街道的交通量将减少/铺设路面时可能会限制通行。
	停车: 施工设备和材料需占用一定空间, 因此正在施工的区域不准停车。如果您停放的车辆影响到施工, 您的车将被免费移至别处。如果您的车被移走, 请致电 416-808-2222 向停车管理部门查询。 如果您在此施工期间收到有关路边停车的交通罚单, 您可以选择按照停车违规通知背面列出的程序对罚单提出异议。 在施工期间, 您可以使用此通知作为您在施工期间在此停车的抗辩证据; 但项目经理无权取消任何违规停车罚单。
	垃圾与回收 请按照正常计划进行。如有需要, 承包商会将垃圾桶或回收桶移至适当位置, 过后再移回原处。 请一定在您的垃圾桶上标出您的地址。
	恢复: 如有需要, 施工区域将使用草皮和/或沥青进行恢复。在施工期间从公共和私人物业移除的连锁砖、碎石基层上的石板或其他类似结构将被重新安置。根据需要将在理想的生长季节 - 春季 (4月至6月) 和秋季 (9月至10月) 播种草籽和/或铺设草皮。
