
Overview

The City of Toronto is carrying out a Transportation Master Plan (TMP) study to address traffic congestion, improve connections for pedestrians and cyclists, and increase access to public transit in the area of St. Clair Avenue West, between Keele Street and Old Weston Road. The Study is being carried out under the Municipal Class Environmental Assessment process and involves the development and evaluation of alternative infrastructure improvements and solutions.

Recommendations

Four infrastructure improvements are being recommended for construction:

- 1. Widen St. Clair Avenue West
- 2. Extend Gunns Road to Union Street
- Extend Keele Street to meet the Gunns Road Extension
- 4. Extend Davenport Road to Union Street



Each recommendation was evaluated to assess traffic movement, travel patterns, travel time and movement; construction and engineering feasibility to determine how solutions would need to be built; costs of construction of each solution; and potential impacts to the natural, cultural, and socioeconomic environment.

The City is working closely with Metrolinx to develop the early design of a new St. Clair-Old Weston SmartTrack Station. The infrastructure improvements identified through the TMP will support access for buses, pedestrians, cyclists and vehicles to the new Station.

1. Widen St. Clair Avenue West

St. Clair Avenue would be widened to the south, between Keele Street and Old Weston Road, to 4 travel lanes with a dedicated streetcar right-of-way. St. Clair Avenue will continue to pass under the rail corridor. The rail bridge needs replacement as well; the two projects would be completed together.




North Side South Side

- Provides the most direct improvement to east-west travel
- Minimizes risk of road blockages for traffic and emergency access
- Integrates pedestrian ramp connection to local streets and the SmartTrack Station
- Opportunity to coordinate work with the replacement of the rail bridges

2. Extend Gunns Road to Union Street

Gunns Road would be extended from Weston Road under the rail corridor to Union Street, providing a new east/west connection.



North Side South Side

- New east-west link improves connections for cyclists, pedestrians, motorists and transit.
- Shifts some transportation demand from St. Clair Avenue.
- Integrates bike and walking links that connect to the Lavender Creek Trail and SmartTrack station.
- Allows TTC bus access to SmartTrack station from Weston Road.

3. Extend Keele Street to meet the Gunns Road Extension

Keele Street would be extended to meet the extension of Gunns Road, improving access to and from the north.



West Side East Side

- Accommodates cyclists, pedestrians, motorists and transit traveling to and from the north, particularly for accessing the SmartTrack station.
- Adds north/south traffic capacity.
- Allows access for TTC route 41 to SmartTrack Station.
- Minimizes traffic infiltration through the local road network.

4. Extend Davenport Road to Union Street

Davenport Road would be extended from Old Weston Road via a new bridge over St. Clair Avenue West to meet Union Street.



West Side East Side

Key features and benefits:

- Improves cyclist, pedestrian, motorist and transit travel to and from south/east, including trips to the SmartTrack station.
- Reduces congestion at the St. Clair / Old Weston intersection.
- Extends Davenport Road cycling facilities with a multi-use trail on the west side, and connects existing cycling routes.

5. Union Street Improvement

Union Street would be improved between Townsley Street and Turnberry Avenue, as part of improved connections between Davenport Road, Keele Street and Gunns Road.
