Watermain Replacement on Civic Centre Court


Contract: 18ECS-LU-02SU Construction Start Date: October 8, 2018 Watermain Completion: December 20, 2018 Permanent Restoration: Spring 2019 *Timeline is subject to change.

The City of Toronto will replace the watermain and the City-owned portion of substandard water services on Civic Centre Court from The West Mall to the East Limit.

The water service is the underground pipe that brings water to your water meter and is owned by you <u>and</u> by the City. The part you own is from your house to the end of your property, the part the City owns is from the end of your property to the watermain.

This project is part of the Council-approved 2018 Capital Works Program to renew our aging infrastructure, improve water distribution and reduce the risk of watermain breaks.

WORK DETAILS

The City's contractor will:

- Excavate the road and dig a trench to access and install the new watermain
- Replace any City-owned water service pipes that do not meet City standards from the watermain to the private property line
- Restore all areas affected by construction
- Resurface areas of the road affected by the watermain replacement.

WHAT TO EXPECT DURING CONSTRUCTION

- You may experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.
- Property owners should remove items located within City property limits (boulevard), such as landscaping and / or decorative objects. If you have a sprinkler system within the boulevard, please contact the Field Ambassador.
- The City will not be responsible for damage to any privately-owned items on City property.

	Extended Work Hours : The Contractor on this project will use extended work hours to minimize traffic disruption and to shorten the project duration. Work will take place from 7 a.m. to 9 p.m. Monday to Friday and 9 a.m. to 7 p.m. on Saturdays.
	Water Service Disruptions: From time-to-time, the water supply to your property will be shut-off to complete construction; the contractor will provide at least 24-hour advance notice. Throughout the work, it is recommended that you temporarily disconnect any water treatment systems (i.e. softeners or filters), water-cooled air conditioners or similar plumbing fixtures. Automatic lawn sprinkler systems may also be affected, therefore, you may need to water manually. In the event you did not received advanced notice, an <i>emergency water shut off</i> could have been necessary.
÷	Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.
	Driveway Access: The contractor will notify you of any temporary restrictions to your driveway access. If your property has two entrances, one entrance will be kept open at all times.
8	Traffic Management : Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.
	Traffic on Civic Centre Court will be reduced to one lane.

Pre-Construction Inspection: OZA Inspections Ltd., under Rabcon Contractors Ltd., will survey all properties adjacent to the construction area before construction starts. Participation in the survey is voluntary; however, participating is important in determining if the construction caused damage. The inspection will look at both the interior and exterior of all properties to verify existing conditions. The company will deliver a separate notice requesting time to set up appointments. All inspection staff will be wearing photo identification and carrying photographic equipment during their work.
