TORONTO LICENSING TRIBUNAL: November 15, 2018 Summary of Decisions V. Romero / M. Calderwood / M. Laverty

Imtiaz Iqbal (Report No. 7076) Holder of Taxicab Owner's Licence No. V02-4312801 AND Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B849785)

DECISION:

Report No. 7076 was withdrawn by Municipal Licensing and Standards, following the letter received on September 20, 2018 from Mr. Iqbal requesting to cancel his application.

(Mr. Imtiaz Iqbal did not attend today's hearing.)

2. Francesco Caruso (Report No. 7040) Applicant for a Tow Truck Driver's Licence (Application No. B827064)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Tow Truck Driver's License will be issued to Francesco Caruso subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of four (4) years. The Applicant is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the Applicant and conduct other investigations, as appropriate, to assess the Applicant's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next four (4) renewals of the licence, Mr. Caruso must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;

- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Caruso or any other concerns with respect to the conduct of the licensee, those matters and report no. 7040 and any updating material, may be brought back before the Tribunal for a full hearing;

DECISION:

The Tribunal approved the following joint Proposed Resolution:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Commencing on November 15, 2018 at 12:00 pm and ending on November 16, 2018 at 12:00 pm, Holistic Centre Owner's Licence will be suspended for a period of one (1) day;
- (3) Immediately upon being renewed, Holistic Centre Owner's Licence will be placed on probation for a period of two (2) years. The Licensee is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the Licensee and conduct other investigations, as appropriate, to assess the Licensee's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against 1713972 Ontario Inc. or Qiang Wang, or any other concerns with respect to the conduct of the licensee, those matters and report no. 7073 and any updating material, may be brought back before the Tribunal for a full hearing.

 Ramesh Auto Services Inc. (Report No. 7055) o/a Ramesh Auto Service Ramsamojh Doodnauth – President Applicant for a Public Garage Licence (Application No. B829371)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Public Garage Licence will be issued to Ramesh Auto Services Inc., subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Public Garage Licence will be placed on probation for a period of three (3) years. Ramsamojh Doodnauth is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Ramsamojh Doodnauth and conduct other investigations, as appropriate, to assess Ramsamojh Doodnauth compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewals of the licence, Ramsamojh Doodnauth must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record.
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Ramsamojh Doodnauth or any other concerns with respect to the conduct of the licensee, those matters and report no. 7055 and any updating material, may be brought back before the Tribunal for a full hearing.

5. Rajendra Muthuthamby (Report No. 7058)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4654616

DECISION:

The Tribunal approved the following joint Proposed Interim Conditions:

Rajendra Muthuthamby's Vehicle-For-Hire Driver's License will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Vehicle-For-Hire Driver's License will be renewed and immediately suspended for one (1) day. Mr. Muthuthamby must surrender his license and photo ID on to Municipal Licensing and Standards on the first day of the suspension;
- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Rajendra Muthuthamby is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Rajendra Muthuthamby and conduct other investigations, as appropriate, to assess Rajendra Muthuthamby's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) Prior to each of the next three (3) renewals of the licence, Rajendra Muthuthamby must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Rajendra Muthuthamby or any other concerns with respect to the conduct of the licensee, those matters and report no. 7058 and any updating material, may be brought back before the Tribunal for a full hearing.

Applicant for a Tow Truck Driver's Licence (Application No. B750194)

DECISION:

The Tribunal adjourned this matter to January 17, 2019 on consent.
