Proposed Motions Process - 1

1. Administrative staff will schedule ONE motion per member a day
2. Administrative staff will advise parties requesting a motion date that we will no longer issue a fixed motion date, however, we will provide the following dates (As per the Rules):
 - Deadline for serving the motion (after the Notice of Election due date)

Due dates to be included in the Notice of Motion

- Deadline for service of the Reply – 7 Calendar days after the service of the motion date
- Deadline for service of the Response – 11 Calendar days after the service of the motion date

Proposed Motions Process - 2

3. Once we receive a perfected motion, we will send out an assignment notification to the assigned member and alert them of the incoming assigned motion and the expected date by which all replies and responses are to be received after which the matter can be considered for disposition.
4. Day 12 – At the completion of the response process, all documents filed including the Notice of Motion, all replies and responses decision template and COA decision in Word, to the assigned Panel Member.
