TORONTO LICENSING TRIBUNAL: October 25, 2018 Summary of Decisions V. Romero / A. Bakshi / G. Yee

1. Abdul Baqi Hadi (Report No. 7025) Applicant for a Tow Truck Driver's Licence (Application No. B825367)

DECISION:

The Tribunal adjourned this matter to December 6, 2018, on consent of both parties, due to time constraints.

2. Ali Farkhondehfall (Report No. 6692) Holder of Taxicab Owner's Licence No. V02-3369983

DECISION:

Report No. 6692 was withdrawn by Municipal Licensing and Standards. Mr. Farkhondehfall sold his Taxicab Owner's Licence plate on Sept. 6, 2018 and the licence has been cancelled.

3. Mohi Uddin (Report No. 7051) Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4722126

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Mohi Uddin's Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. The Licensee is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the Licensee and conduct other investigations, as appropriate, to assess the Licensee's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Uddin or any other concerns with respect to the conduct of the licensee, those matters and report no. 7051, and any updating material, may be brought back before the Tribunal for a full hearing.
- **4. Sabithan Santhiraseelan** (Report No. 7048) Applicant for a Tow Truck Driver's Licence (Application No. B835143)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Tow Truck Driver's Licence will be issued to Sabithan Santhiraseelan, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of four (4) years. The Applicant is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against the Applicant and conduct other investigations, as appropriate, to assess the Applicant's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) During the probationary period and for the first two yearly renewals of the licence, Mr. Santhiraseelan must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record every six (6) months; and every year for the third and fourth years.
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Santhiraseelan or any other concerns with respect to the conduct of the licensee, those matters and report no. 7048 and any updating material, may be brought back before the Tribunal for a full hearing.

5. Estate of Paul Geiger (Report No. 7093) Susan Holtzman- Estate Trustee George Geiger- Estate Trustee Holder of Taxicab Owner's Licence No.: V02-4738774 and V02-4738777 Taxicab Plate No.: 3012 and 1834

DECISION:

The Tribunal extended Taxicab Owner's Licenses V02-4738774 and V02-4738777 for Taxicab Plate Nos. 3012 and 1834 to remain in the Estate of Paul Geiger for one year (from September 6, 2018 to September 6, 2019).

6. Fahd Haddad (Report No. 7060) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B836408)

DECISION:

The Tribunal adjourned this matter to November 29, 2018 at the request of Mr. Haddad.

(Mr. Haddad did not attend today's hearing)

7. Ennead Ltd. (Report No. 7046)

o/a Sunrise Caribbean Restaurant Kedon Orlando Walker- Director Applicant for a Motorized Refreshment Vehicle Licence (Application No. B833722)

DECISION:

The Tribunal adjourned this matter to November 29, 2018 at the request of Mr. Walker.

(Mr. Walker did not attend today's hearing)

8. Cemone Camele Clarke (Report No. 7047)

Applicant for a Tow Truck Driver's Licence (Application No. B829085)

DECISION:

The Tribunal dismissed Ms. Clarke's application for a Tow Truck Driver's Licence.

(Ms. Clarke failed to attend today's hearing)

9. Shamim Chowdhury (Report No. 6969)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4430475

DECISION:

The Tribunal adjourned this matter to December 13, 2018 on consent. The Tribunal issued an interim order to suspend Mr. Chowdhury's Vehicle-For-Hire Driver's Licence. Mr. Chowdhury is to surrender his Vehicle-For-Hire Driver's Licence and photo card to Municipal Licensing and Standards today. A Bengali interpreter will be provided for Mr. Chowdhury.

10. Golam Mustafa (Report No. 7084)

Holder of Vehicle-For-Hire Driver's Licence No. D01-3250234

DECISION:

The Tribunal adjourned this matter sine die pending the outcome of the criminal proceedings. The Tribunal placed the following interim conditions on Mr. Golam Mustafa's Vehicle-For-Hire Driver's Licence No. D01-3250234 on a temporary basis pending the outcome of the Tribunals final decision:

- (1) Mr. Mustafa shall not operate a taxi with an unaccompanied female passenger;
- (2) No female passenger is allowed in the front seat of the Taxicab
- (3) Mr. Mustafa is not allowed to operate a Taxicab/Limousine between the hours of 9:00 pm and 7:00 am.
- (4) Mr. Mustafa must surrender his Vehicle-For-Hire Driver's Licence and photo ID to Municipal Licensing and Standards tomorrow. The above temporary conditions will be updated on his licence and photo ID.
- (5) Mr. Mustafa shall inform Municipal Licensing and Standards of any disposition of the criminal charge, in writing, within five (5) business days. Mr. Mustafa can notify Municipal Licensing and Standards in one of the following ways:
