# TORONTO LICENSING TRIBUNAL: November 22, 2018 Summary of Decisions A. Bakshi / D. Simon / V. Romero

#### **1. Zafar Khan** (Report No. 7059) Holder of Vehicle-For-Hire Driver's Licence No. D01-4308954

### **DECISION:**

The Tribunal adjourned this matter sine die, pending the availability of a Toronto Police Services witness.

 K.H. (Report No. 6967) Applicant for the Renewal of Toronto Taxicab Owner's Licence AND Applicant for a Vehicle-For-Hire Driver's Licence

#### DECISION:

The Tribunal adjourned this matter to January 17, 2019. Preliminary motions will be heard on January 17, 2019. The applicant must file all motion materials no later than January 7, 2019, and the respondent's motion materials must be filed no later than January 14, 2019.

The Tribunal ordered this matter be brought back before a panel on February 7, 2019, for a full hearing of the matter.

#### 3. Gurjeet Singh Samra (Report No. 7064)

Applicant for a Tow Truck Driver's Licence (Application No. B837855)

#### **DECISION:**

The Tribunal approved the following joint Proposed Resolution:

Tow Truck Driver's Licence will be issued to Gurjeet Singh Samra, subject to the following conditions:

(1) All fees, documents and/or any outstanding requirements must be

submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;

- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of four (4) years. Gurjeet Singh Samra is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Gurjeet Singh Samra and conduct other investigations, as appropriate, to assess Gurjeet Singh Samra's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next four (4) renewals of the licence, Gurjeet Singh Samra must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Gurjeet Singh Samra or any other concerns with respect to the conduct of the licensee, those matters and report no. 7064 and any updating material, may be brought back before the Tribunal for a full hearing.

## 4. 10241318 Canada Inc. (Report No. 7043)

o/a Yala Habibiz Ali Ballout, President Holder of Eating Establishment Licence No. B71-4741642

#### **DECISION:**

Eating Establishment Licence No. B71-4741642 is cancelled as of November 1, 2018. Report No. 7043 was withdrawn by Municipal Licensing and Standards.

(Ms. Meenakshi Lakhanpal, Legal representative for Mr. Ballout advised that Mr. Ballout requested the cancellation of his licence on October 30, 2018.)
