

Baby Point Wastewater Pumping Station Forcemain

Municipal Class Environmental Assessment - Notice of Study Completion


The City of Toronto has completed a Municipal Class Environmental Assessment (EA) Schedule B Study to explore opportunities to improve reliability of an aging forcemain (sewer) that serves the Baby Point Wastewater Pumping Station. The existing forcemain is located within Étienne Brûlé Park.

Following consultation with agencies, City Divisions and the public, the following are the study's key findings, accepted by the City:

New forcemain along the approximate alignment of the existing forcemain from the Baby Point Pumping Station west through Étienne Brûlé Park adjacent to the Humber River, crossing under the Humber River and terminating at Adit No. 7, which is an access tunnel to the Humber Creek Sanitary Trunk Sewer located along The Kingsway.

Opportunities for review

The study was carried out following the requirements for Schedule B projects under the Municipal Class EA process. A Project File has been placed on public record for a 30-day review period starting November 15, 2018 and ending on December 17, 2018 and it is available for review at www.toronto.ca/babypointstudy or at:
