DECISION:

The Tribunal adjourned this matter to January 24, 2019 and to continue on February 14, 2019.

Christopher Tan (Report No. 7080)
o/a Christopher Tan
Applicant for a Public Garage Licence (Application No. B851970)

DECISION:

The Tribunal approved the following amendment to the originally signed Proposed Resolution of October 16, 2018:

A Public Garage Drivers Licence Licence will be issued to Christopher Tan.

Para (2): Immediately upon being issued, the Public Garage Drivers Licence will be placed on probation for a period of one (1) year.

The Tribunal approved the following joint Proposed Resolution:

A Public Garage Licence will be issued to Christopher Tan, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, the Public Garage Licence will be placed on probation for a period of one (1) year. Christopher Tan is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Christopher Tan and conduct other investigations, as appropriate, to assess Christopher Tan's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next one (1) renewal of the licence, Christopher Tan must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Christopher Tan or any other concerns with respect to the conduct of the licensee, those matters and report no. 7080 and any updating material, may be brought back before the Tribunal for a full hearing.
- **3. Fahd Haddad** (Report No. 7060) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B836408)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Vehicle-For-Hire Driver's Licence will be issued to Fahd Haddad, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Haddad is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Haddad and conduct other investigations, as appropriate, to assess Mr. Haddad's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Fahd Haddad or any other concerns with respect to the conduct of the licensee, those matters and report no. 7060 and any updating material, may be brought back before the Tribunal for a full hearing.
- Ennead Ltd. (Report No. 7046) o/a Sunrise Caribbean Restaurant Kedon Orlando Walker, Director Applicant for a Motorized Refreshment Vehicle Licence (Application No. B833722)

DECISION:

The Tribunal dismissed Report No. 7046. Mr. Walker advised the Toronto Licensing Tribunal Administration that he wishes to cancel his application for a Motorized Refreshment Vehicle Licence.

5. Ghulam Rasool Razai (Report No. 7090) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B857006)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Vehicle-For-Hire Driver's Licence will be issued to Ghulam Rasool Razai, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Ghulam Rasool Razai is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Ghulam Rasool Razai and conduct other investigations, as appropriate, to assess Ghulam Rasool Razai's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

(3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Ghulam Rasool Razai or any other concerns with respect to the conduct of the licensee, those matters and report no. 7090 and any updating material, may be brought back before the Tribunal for a full hearing.

6. Abdulsalam Shahmehr (Report No. 7128)

Holder of Vehicle-For-Hire Driver's Licence D01-4701250 AND Holder of Taxicab Owner's Licence No. V00-4426695, Taxicab Plate No. 4210

DECISION:

The Tribunal adjourned this matter sine die pending the outcome of the criminal proceedings.

The Tribunal placed the following interim conditions on Mr. Shahmehr's Vehicle-For-Hire Driver's Licence No. D01-4701250 on a temporary basis pending the outcome of the criminal charges:

- (1) Mr. Shahmehr shall not accept fares from any unaccompanied female passenger;
- (2) No female passenger is allowed in the front seat of the Taxicab;
- (3) Mr. Shahmehr shall not accept any passenger fares between the hours of 9:00 p.m. and 7:00 a.m.;
- (4) Mr. Shahmehr must provide his Vehicle-For-Hire Driver's Licence and photo ID to Municipal Licensing and Standards, no later than Friday November 30th, 2018. The above temporary conditions will be updated on his licence and photo ID.
