# TORONTO LICENSING TRIBUNAL: December 6, 2018 Summary of Decisions A. Bakshi / V. Romero / M. Calderwood

1. Arunagirinathan Kobynathan (Report No. 7062)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-3362973

#### **DECISION:**

The Tribunal approved the following joint Proposed Resolution:

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Vehicle-For-Hire Driver's Licence will be renewed and immediately suspended for two (2) days; Mr. Kobynathan must surrender his licence and photo card to Municipal Licensing and Standards on the first day of suspension. The suspension will take place between 9:00 am Monday December 10, 2018 to 9:00 am Wednesday December 12, 2018;
- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years.
