The City's contractor will begin Phase 2 work on February 4, 2019. Advancing Phase 2 work will be in two parts – Phase 2A and Phase 2B to keep the construction schedule completion date of Spring 2021. See the revised construction schedule overview chart and map for Phase 2A on the reverse.
