
TORONTO LICENSING TRIBUNAL: February 21, 2019
Summary of Decisions

1. Rameen Zafari (Report No. 7091)

Applicant for the Renewal of Tow Truck Driver's Licence D09-4737183

DECISION:

The Tribunal adjourned this matter to April 18, 2019. Mr. Zafari requested an adjournment in order to retain legal representation.

The Tribunal advised Mr. Zafari to inform his legal representative when retained, to contact the Tribunal office and to be available on April 18, 2019.

2. Nabil Ahmad Amem (Report No. 7125)

Applicant for the Renewal of Tow Truck Driver's Licence D09-4665468

DECISION:

The Tribunal approved the joint Proposed Resolution:

Mr. Amem's Tow Truck Driver's Licence will be renewed, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence will be cancelled;
- (2) Immediately upon being renewed, Mr. Amem's Tow Truck Driver's Licence will be suspended for a period of twenty (20) days beginning on February 21, 2019 and running to March 12, 2019, inclusive. Mr. Amem must surrender his Tow Truck Driver's License and his photo card to Municipal Licensing and Standards immediately after this hearing;
- (3) Immediately upon being renewed, Tow Truck Driver's Licence will be placed on probation for a period of two (2) years. Mr. Amem is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Amem and conduct other investigations, as appropriate, to assess Mr. Amem's compliance with the requirements of Chapter 545 of the

Municipal Code and other applicable laws;

- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions, those matters and report No. 7125, and any updating material, shall be brought back before the Tribunal for a full hearing.

Mr. Amem is permitted to pick up his licence and photo card ID at 3:30 p.m. on March 12, 2019, however the licence will remain under suspension until midnight (12:00 am) at which the suspension will be lifted.

3. Wahid Ahmad Kabir (Report No. 7031)

Holder of Vehicle-For-Hire Driver's Licence No. D01-4656840

DECISION:

Report No. 7031 was withdrawn by Municipal Licensing and Standards. Mr. Kabir failed to renew his Vehicle-For-Hire Driver's Licence. The licence was cancelled on November 19, 2018.

(Mr. Kabir did not attend today's hearing)

4. Salahadin Sharif Yousuf (Report No. 7109)

Holder of Vehicle-For-Hire Driver's Licence No. D01-4655235

DECISION:

The Tribunal adjourned this matter to April 11, 2019.

Mr. Yousuf is no longer in agreement with the Proposed Resolution originally signed on January 8, 2019 and requested an adjournment of today's hearing in order to retain legal representation, and wishes to proceed with a full hearing. The previously signed Proposed Resolution is void.

The Tribunal advised Mr. Yousuf to provide the Tribunal with contact information of his legal representative as soon as possible.

5. Joseph M. Sakoir (Report No. 7159)

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B881235)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on January 22, 2019:

Vehicle-For-Hire Driver's Licence will be issued to Joseph M. Sakoir, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Joseph M. Sakoir is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Joseph M. Sakoir and conduct other investigations, as appropriate, to assess Joseph M. Sakoir's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Joseph M. Sakoir or any other concerns with respect to the conduct of the licensee, those matters and report no. 7159 and any updating material, may be brought back before the Tribunal for a full hearing.
