# TORONTO LICENSING TRIBUNAL: January 3, 2019 Summary of Decisions D. Simon / M. Calderwood / M. Laverty

### Shawn Shun Gee Tsai (Report No. 7111) o/a Skinart Tattoo Applicant for a Personal Services Settings Licence (Application No. B864222)

#### **DECISION:**

Personal Services Settings Licence will be issued to Shawn Shun Gee Tsai, subject to the following conditions:

The Tribunal ordered the following Amendment to condition 1;

All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within **90 days** of the Tribunal hearing, failing which the application may be cancelled;

The Tribunal approved the following joint Proposed Resolution, originally signed on November 13, 2018:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within <del>30 days</del> of the Tribunal hearing, failing which the application may be cancelled;

#### **DECISION:**

The Tribunal agreed to adjourn this matter sine die at the request of Municipal Licensing and Standards. MLS requested additional documentation to be filed by the Estate Trustee in order to complete the Transfer of the licence.

Once all documentation has been submitted to the satisfaction of MLS, a new report with updated information will be brought forward at a future hearing date.

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Tow Truck Driver's Licence will be immediately suspended for one (1) day. Mr. Jillany must surrender his licence and photo card to Municipal Licensing and Standards on the first day of the suspension;
- (3) Tow Truck Driver's Licence will be placed on probation for a period of two (2) years. # Vivid Bar Lounge Inc. (Report No. 6819) o/a Vivid Bar Lounge Victor Dionisio, Director Appicant for Renewal of Eating Establishment Licence No. B71-4421880

#### DECISION:

The Tribunal approved the following joint Proposed Resolution:

Eating Establishment Licence No. B71-4421880 will be renewed, subject to the following conditions:

- (1) All outstanding by-law fines registered against Vivid Bar Lounce Inc., o/a Vivid Bar Lounge must be paid within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, the Eating Establishment Licence will be placed on probation for a period of two (2) years;
- (3) Vivid Bar Lounge Inc. shall continue to take steps to address the noise concerns with respect to its premises at 1067 St. Clair Avenue West, including but not limited to effectively monitoring both the volume of its entertainment system at all times and the behaviour of patrons outside of its premises during Vivid Bar Lounge's operating hours; and
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Vivid Bar Lounge Inc. or Victor Dionisio, those matters and report No. 6819, and any updating material, may be brought back before the Tribunal for a full hearing.

# Matias Abebe Fikade (Report No. 7050) Holder of Vehicle-For-Hire Driver's Licence No. D01-4739731

#### **DECISION:**

The Tribunal adjourned this matter pending the outcome of the criminal proceedings. The interim suspension ordered on Mr. Fikade's Vehicle-For-Hire Driver's Licence on September 27, 2018 remains in effect.
