
TORONTO LICENSING TRIBUNAL: December 13, 2018
Summary of Decisions

- 1. Ahmad Nasir Ahmadshahi (Report No. 7053)**
Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-3837970

DECISION:

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) Immediately upon being renewed, the Vehicle-For-Hire Driver's Licence will be suspended for a period of one (1) day. Mr. Ahmad Nasir Ahmadshahi must surrender his licence and photo card to Municipal Licensing and Standards on the first day of the suspension;
- (3) Immediately upon being renewed, the Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Ahmad Nasir Ahmadshahi is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against him and conduct other investigations, as appropriate, to assess his compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) Prior to each of the next three (3) renewals of the licence, Ahmadshahi must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;
- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Ahmad Nasir Ahmadshahi or any other concerns with respect to the conduct of the licensee, those matters and report no. 7053 and any updating material, may be brought back before the Tribunal for a full hearing.

Applicant for Renewal of Body Rub Parlour Owner/Operator Licence No. B38-4532624

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Body Rub Parlour Owner/Operator Licence will be renewed, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the Body Rub Parlour Owner/Operator Licence may be cancelled;
- (2) The Body Rub Parlour Owner/Operator Licence shall be suspended for a period of ten (10) days, beginning on December 24, 2018 and continuing to the end of January 2, 2019;
- (3) Any fines arising out of pending by-law charges against 1133520 Ontario Inc., as shown in Report No. 6893, shall be paid within the time provided by the court, failing which the Body Rub Parlour Owner/Operator Licence shall be suspended until payment of the fines is made and Municipal Licensing and Standards is satisfied with proof of same;
- (4) Immediately upon being renewed, the Body Rub Parlour Owner/Operator Licence will be placed on probation for a period of three (3) years;
- (5) Prior to each of the next three (3) renewals of the Body Rub Parlour Owner/Operator Licence, 1133520 Ontario Inc. must provide to Municipal Licensing and Standards, at its own expense, an original up-to-date abstract of Malgorzata Koska's criminal record;
- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against 1133520 Ontario Inc. and/or Malgorzata Koska, those matters and Report No. 6893, and any updating material, may be brought back before the Tribunal for a full hearing.

3. Shamim Chowdhury (Report No. 6969)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4430475

DECISION:

The Tribunal adjourned this matter to January 24, 2019. The interim suspension ordered on Mr. Chowdhury's Vehicle-For-Hire Driver's Licence No. D01-4430475 on October 25, 2018 will remain in effect until such time the Tribunal orders otherwise.

4. Muhammad Adnan Anwar (Report No. 7118)

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B873083)

DECISION:

The Tribunal approved the following joint Proposed Resolution:

Vehicle-For-Hire Driver's Licence will be issued to Muhammad Adnan Anwar, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Mr. Anwar is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Anwar and conduct other investigations, as appropriate, to assess Mr. Anwar's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next two (2) renewals of the licence, Muhammad Adnan Anwar must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Muhammad Adnan Anwar or any other concerns with respect to the conduct of the licensee, those matters and report no. 7118 and any updating material, may be brought back before the Tribunal for a full hearing.
