TORONTO LICENSING TRIBUNAL: March 7, 2019 Summary of Decisions D. Simon / A. Bakshi / V. Romero

1. Mahboobshah Haqpanah (Report No. 7110)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4652187

DECISION:

The Tribunal adjourned this matter to March 28, 2019.

- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Gorgees or any other concerns with respect to the conduct of the licensee, those matters and report no. 7146 and any updating material, may be brought back before the Tribunal for a full hearing.

DECISION:

DECISION:

The Tribunal approved the joint Proposed Resolution originally signed on March 7, 2019:

Vehicle-For-Hire Driver's Licence is subject to the following conditions:

- (1) Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Mr. Tsegai is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Tsegai and conduct other investigations, as appropriate, to assess Mr. Tsegai's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Suppiramanim is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Suppiramanim and conduct other investigations, as appropriate, to assess Mr. Suppiramanim's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Suppiramanim or any other concerns with respect to the conduct of the licensee, those matters and report no. 7130 and any updating material, may be brought back before the Tribunal for a full hearing.
