TORONTO LICENSING TRIBUNAL: February 28, 2019 Summary of Decisions M. Laverty / M. Calderwood / V. Romero

1. Mohammad Shah Jahan (Report No. 7150)
Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B878755)

DECISION:

The Tribunal issued Vehicle-For-Hire Driver's Licence, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Jahan is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Jahan and conduct other investigations, as appropriate, to assess Mr. Jahan's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewals of the licence, Mr. Jahan must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his Criminal Record and Judicial Matters Check and Driver's Record Abstract;
- (4) During the probationary period, if Mr. Jahan incurs any alcohol related charges and/or convictions, he must notify Municipal Licensing and Standards, in writing, within three (3) business days. The notification shall include his ML&S licence number and the ticket number(s). Mr.

- (5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Jahan or any other concerns with respect to the conduct of the licensee, those matters and report no. 7150 and any updating material, may be brought back before the Tribunal for a full hearing.

2. Estate of Keith Orlando Bogle (Report No. 7151)

DECISION:

The Tribunal extended Taxicab Owner's Licence No. V02-4811918 for Taxicab Plate No. A456 to remain in the Estate of Keith Orlando Bogle until April 30, 2019.

3. Fasial Ashraf (Report No. 7144)

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B879698)

DECISION:

The Tribunal denied Fasial Ashraf's application for a Vehicle-For-Hire Driver's Licence. The Tribunal determined that it is too soon to be assured that Mr. Ashraf has carried on or will carry on his business in accordance with the Law and with honesty and integrity. Mr. Ashraf is welcome to apply again in the future.

4. 7580584 Canada Ltd. (Report No. 7169)

o/a Harvey's Jaipaul Jerry Persaud, Director Rabia Husain, Director Applicant for an Eating Establishment Licence (Application No. B864231)

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on February 5, 2019:

Eating Establishment Licence will be issued, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled:
- (2) After being issued, Eating Establishment Licence will be suspended for three (3) days to be served on March 10, 2019, March 17, 2019 and March 24, 2019;
- (3) Immediately upon being issued, Eating Establishment Licence will be placed on probation for a period of two (2) years. Mr. Persaud and Ms. Husain are advised that during the probationary period, MLS may make additional checks of any criminal, and by-law charges and convictions against Mr. Persaud, Ms. Husain and 7580584 Canada Ltd. and conduct other investigations, as appropriate, to assess the compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Persaud, Ms. Husain and 7580584 Canada Ltd. or any other concerns with respect to the conduct of the licensee's, including the corporate directors/officers, those matters and report no. 7169 and any updating material, may be brought back before the Tribunal for a full hearing.
