

Contract: 17ECS-TI-07BE Expected Start Date: March 19, 2019 Expected End Date: May 31, 2019 \*Timeline is subject to change. Future notice to be provided.

The City of Toronto is planning to repair the east approach slab and repave the Crescent Road Bridge over TTC at Rosedale Station. This work will ensure that the bridge meets today's standards and remains safe for vehicles and pedestrians into the future. The project is part of the Councilapproved 2019 Capital Works Program.

|                | <b>Work Hours</b> : Work will take place from 7 a.m. to 7 p.m., Monday to Friday, with work after hours and on weekends as required.   |

| ••             | Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work area.<br>One sidewalk will remain open at all times with closures on the north and south side of Crescent Road alternating.  |
| 8              | <b>Traffic Management</b> : Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.   |
