TORONTO LICENSING TRIBUNAL: March 28, 2019
Summary of Decisions
V. Romero / M. Calderwood / M. Laverty

- 1. Gurcharan Singh** (Report No. 7177)
Holder of Vehicle-For-Hire Driver's Licence No. D01-4866750

DECISION:

The Tribunal ordered an interim suspension, effective today March 28, 2019 on Mr. Singh's Vehicle-For-Hire Driver's Licence pending the resolution of his criminal proceedings.

At any time prior to the completion of the criminal proceedings, if there are any developments or evidence, either party; Municipal Licensing and Standards or Mr. Singh can request to bring back the matter back before the Tribunal. The Tribunal further ordered that Mr. Singh surrender his Vehicle-For-Hire Driver's Licence and Photo ID to Municipal Licensing and Standards immediately.

- 2. Nasir Inyat** (Report No. 7074)
Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B842295)

DECISION:

The Tribunal approved the request for adjournment of this matter to April 25, 2019, on consent.

Mr. Stewart requested an adjournment on behalf of Mr. Inyat, in order for Mr. Inyat to provide supporting documentation of his matter to Municipal Licensing and Standards.

3. Estate of Haya Hella Rosenbloom (Report No. 7214)

Haim Rosenblum, Estate Trustee

Holder of Taxicab Owner's Licence No. V02-4835158, Taxicab Plate No. 1853

DECISION:

The Tribunal extended Taxicab Owner's Licence V02-4835158 to remain in the Estate of Haya Hella Rosenbloom until March 22, 2020.

4. Mahboobshah Haqpanah (Report No. 7110)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4652187

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on January 22, 2019:

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be suspended for a period of five (5) days;
- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mahboobshah Haqpanah is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mahboobshah Haqpanah and conduct other investigations, as appropriate, to assess Mahboobshah Haqpanah's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mahboobshah Haqpanah or any other concerns with respect to the conduct of the licensee, those matters and report no. 7110 and any updating material, may be brought back before the Tribunal for a full hearing.

5. Raja Sinnaraja (Report No. 7108)

Applicant for the Renewal of Tow Truck Driver Licence No. D09-4739639

DECISION:

The Tribunal approved the following:

Tow Truck Driver's Licence will be renewed, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing (unless otherwise noted), failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Tow Truck Driver's Licence will be suspended for a period of thirty (30) days until April 27, 2019;
- (3) Mr. Sinnaraja must provide to the satisfaction of Municipal Licensing and Standards, proof of successful completion of a Ministry approved driving improvement course. This course must be a minimum of 8 hours total duration of which some component must include in-vehicle training. Mr. Sinnaraja must provide the proof prior to April 27, 2019. The 30 day suspension (condition 2) will not be lifted, until this condition is not met; the suspension will be extended beyond April 27, and continue until the above condition is met;
- (4) Immediately upon being renewed, Tow Truck Driver's Licence will be placed on probation for a period of four (4) years. Mr. Sinnaraja is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Sinnaraja and conduct other investigations, as appropriate, to assess Mr. Sinnaraja's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (5) Prior to each of the next four (4) renewals, Mr. Sinnaraja must provide to Municipal Licensing and Standards an original up-to-date abstract of his driving record;
- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Sinnaraja or any other concerns with respect to the conduct of the licensee, those matters and report no. 7108 and any updating material, may be brought back before the Tribunal for a full hearing;
- (7) Mr. Sinnaraja must surrender his Tow Truck Driver's Licence and photo ID to Municipal Licensing and Standards by tomorrow (March 29, 2019) by 4:00 pm.
