TORONTO LICENSING TRIBUNAL: April 4, 2019 Summary of Decisions M. Calderwood / D. Simon / A. Bakshi

1. Sugantharajan Srikrishnarajah (Report No. 7117) Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D05-4538153

DECISION:

The Tribunal approved the following joint Proposed Resolution, originally signed on January 22, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be suspended for a period of two (2) days;
- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Sugantharajan Srikrishnarajah is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Sugantharajan Srikrishnarajah and conduct other investigations, as appropriate, to assess Sugantharajan Srikrishnarajah's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Sugantharajan Srikrishnarajah or any other concerns with respect to the conduct of the licensee, those matters and report no. 7117 and any updating material, may be brought back before the Tribunal for a full hearing.

2. Aqeel Ahmed (Report No. 7172)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4543962

DECISION:

The Tribunal approved the following joint Proposed Resolution, originally signed on March 19, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Mr. Ahmed is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Ahmed and conduct other investigations, as appropriate, to assess Mr. Ahmed's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Ahmed or any other concerns with respect to the conduct of the licensee, those matters and report no. 7172 and any updating material, may be brought back before the Tribunal for a full hearing.

3. Mohamed Awad Ali (Report No. 7164)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-3110081

DECISION:

The Tribunal adjourned this matter sine die on the following terms:

- (1) Mr. Ali's Vehicle-For-Hire Driver's Licence is deemed to continue in the interim until and unless the Tribunal orders otherwise;
- (2) In accordance with rule 15(1) of the Toronto Licensing Tribunal Rules of Procedure, the Tribunal on its own initiative directs that a prehearing conference be held in this proceeding and the parties participate in this conference as expressed in sub-paragraph (h) of section 15(1) of the Rules of Procedure. The purpose of the prehearing will include a mediation of any or all outstanding issues in

dispute;

- (3) An Arabic interpreter be made available to the licensee at the prehearing, given the circumstances that have arisen in this case.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. Mr. Remshani is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Remshani and conduct other investigations, as appropriate, to assess Mr. Remshani's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Remshani or any other concerns with respect to the conduct of the licensee, those matters and report no. 7155 and any updating material, may be brought back before the Tribunal for a full hearing.
- 5. Sureshwaran Muthathamby (Report No. 7115) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B863432)

DECISION:

The Tribunal approved the following joint Proposed Resolution, originally signed on March 5, 2019.

Vehicle-For-Hire Driver's Licence will be issued to Sureshwaran Muthathamby, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Muthathamby is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Muthathamby and conduct other investigations, as appropriate, to assess Mr. Muthathamby's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewals of the licence, Mr. Muthathamby must provide to Municipal Licensing and Standards, at his own expense, an original up-to-date abstract of his criminal record and judicial matters check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Muthathamby or any other concerns with respect to the conduct of the licensee, those matters and report no. 7115 and any updating material, may be brought back before the Tribunal for a full hearing.

6. Peter Kwasi Atuahene (Report No. 7160)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-1029733

DECISION:

The Tribunal approved the following joint Proposed Resolution, originally signed on March 5, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of one (1) year. Mr. Atuahene is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Atuahene and conduct other investigations, as appropriate, to assess Mr. Atuahene's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Atuahene or any other concerns with respect to the conduct of the licensee, those matters and report no. 7160 and any updating material, may be brought back before the Tribunal for a full hearing.
- 7. Chaudhry Ali Ijaz Cheema (Report No. 7190) Holder of Vehicle-For-Hire Driver's Licence No. D01-4816244

DECISION:

The Tribunal adjourned this matter sine die on the following terms:

- (1) Mr. Cheema's Vehicle-For-Hire Driver's Licence is deemed to continue in the interim until the Tribunal orders otherwise;
- (2) In accordance with rule 4.(1) of the Toronto Licensing Tribunal Rules of Procedure state that in any proceeding the TLT may issue procedural orders which shall govern the conduct of the proceeding. In accordance with rule 15.(1) of the Toronto Licensing Tribunal Rules of Procedure, the Tribunal on its own initiative directs that a pre-hearing conference be held in this proceeding and the parties participate in this conference as expressed in sub-paragraph (h) of section 15.(1) of the Rules of Procedure. The purpose of the pre-hearing will include a mediation of any or all outstanding issues in dispute;
- (3) A Hindi interpreter be made available to the licensee at the prehearing, given the circumstances that have arisen in this case.
- 8. Mohammad Shafiq (Report No. 7119) Holder of Vehicle-For-Hire Driver's Licence No. D01-4758013

DECISION:

The Tribunal adjourned this matter to April 25, 2019 on consent.
