TORONTO LICENSING TRIBUNAL: May 2, 2019 Summary of Decisions M. Laverty / M. Lee / D. Simon

Mathinishanth Sooriyakumar (Report No. 7166)
 Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4749365

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on March 5, 2019.

Tow Truck Driver's Licence will be renewed, subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled:
- (2) Tow Truck Driver's Licence will be renewed and suspended for two (2) days; Mr. Sooriyakumar must surrender his licence and photo card to Municipal Licensing and Standards on the first day of the suspension. The suspension will take place between 9:00 a.m. May 6th, 2019 to 9:00 a.m. May 8th, 2019;
- (3) Immediately upon being renewed, Tow Truck Driver's Licence will be placed on probation for a period of four (4) years. Mathinishanth Sooriyakumar is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Sooriyakumar and conduct other investigations, as appropriate, to assess Mr. Sooriyakumar's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;

The Tribunal approved the joint Proposed Resolution, originally signed on April 2, 2019.

Vehicle-For-Hire Driver's Licence will be subjected to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled:
- (2) Vehicle-For-Hire Driver's Licence will be placed on probation for a period of four (4) years. Mr. Talukder is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Talukder and conduct other investigations, as appropriate, to assess Mr. Talukder's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of three (3) years. Mr. Noori is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Noori and conduct other investigations, as appropriate, to assess Mr. Noori's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) years renewals of the licence, Mr. Noori must provide to Municipal Licensing and Standards, at their own expense, an original up-to-date abstract of their Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Noori or any other concerns with respect to the conduct of the licensee, those matters and report no. 7189 and any updating material, may be brought back before the Tribunal for a full hearing.

4. Ronald Michael Penney (Report No. 7198)

- (2) Immediately upon being issued, Tow Truck Driver's Licence will be placed on probation for a period of three (3) years. Mr. Penney is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Penney and conduct other investigations, as appropriate, to assess Mr. Penney's compliance with the requirements of Chapter 545 of the Municipal Code and other applicable laws;
- (3) Prior to each of the next three (3) renewals of the licence, Mr. Penney must provide to Municipal Licensing and Standards, at their own expense, an original up-to-date abstract of their Criminal Record and Judicial Matters Check;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Penney or any other concerns with respect to the conduct of the licensee, those matters and report no. 7198 and any updating material, may be brought back before the Tribunal for a full hearing.
