- Rates cannot be altered unless updated rates are filed with Municipal Licensing and Standards.
- The rates shall be based solely on time, distance and additional service.
- Where rates vary according to time of day or geographical zones, the basis for such variance shall be clearly set out in the filed rates.
- Rates filed must be clearly defined or they will not be accepted (must specify maximum charges).

**Rates should be provided for vehicles over 3,175 kilograms (7,000 pounds), if not, under 3,175 kilogram (7,000 pound) rates will apply.**
