TORONTO LICENSING TRIBUNAL: April 18, 2019 Summary of Decisions V. Romero / G. Yee / M. Carter-Whitney

1. Rameen Zafari (Report No. 7091) Applicant for the Renewal of Tow Truck Driver's Licence No. D09-4737183

DECISION:

The Tribunal approved the request for adjournment.

The Tribunal adjourned this matter to May 30, 2019, on consent, subject to the following conditions:

Mr. Robert Stewart, Paralegal for Mr. Zafari, requested an adjournment to June 20, 2019. The Tribunal ordered this matter to be adjourned to May 30, 2019, pending Mr. Stewart's availability.

Mr. Stewart is required to contact the Tribunal by May 1, 2019 to advise of his attendance. If Mr. Stewart cannot attend on May 30, 2019 the matter will go ahead on June 20, 2019, peremptory to Mr. Zafari.

Salahadin Sharif Yousuf (Report No. 7109) Holder of Vehicle-For-Hire Driver's Licence No. D01-4655235

DECISION:

The Tribunal approved the joint Proposed Resolution, signed on April 18, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions: Amendment to condition 1

 Vehicle-For-Hire Driver's Licence will be suspended for a period of two (2) days, commencing on April 23, 2019;

- (2) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Yousuf is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Yousuf and conduct other investigations, as appropriate, to assess Mr. Yousuf's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Yousuf or any other concerns with respect to the conduct of the licensee, those matters and report No. 7109, and any updating material, may be brought back before the Tribunal for a full hearing.

Mr. Yousuf must surrender his licence and photo card to Municipal Licensing and Standards, on April 23, 2019.

3. Abdullahi Ali Jama (Report No. 7086)

Holder of Vehicle-For-Hire Driver's Licence No. D01-4541975

DECISION:

The Tribunal approved the joint Proposed Resolution, signed on April 18, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- Vehicle-For-Hire Driver's Licence will be suspended for a period of two (2) days, commencing on Tuesday, April 23, 2019;
- (2) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Jama is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Jama and conduct other investigations, as appropriate, to assess Mr. Jama's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

(4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Jama, those matters and report No. 7086, and any updating material, may be brought back before the Tribunal for a full hearing.

Mr. Jama must surrender his licence and photo card to Municipal Licensing and Standards, on April 23, 2019.

4. Abdul Haseeb Bekzad (Report No. 7156)

Holder of Vehicle-For-Hire Driver's Licence No. D01-4825407

DECISION:

The Tribunal approved the joint Proposed Resolution, signed on April 18, 2019 by Ms. Andrea Toth, on behalf of Mr. Bekzad.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions:

- Vehicle-For-Hire Driver's Licence will be suspended for a period of two (2) days, effective immediately;
- (2) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Bekzad is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Bekzad and conduct other investigations, as appropriate, to assess Mr. Bekzad's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Bekzad or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7156 and any updating material, may be brought back before the Tribunal for a full hearing.
