Bridge Rehabilitation Evans Avenue over Brown's Line

Contract: 19-ECS-TI-10BE Expected Start Date: May 15, 2019* Expected End Date: October 31, 2020* *Timeline is subject to change.

The City of Toronto will rehabilitate the Evans Avenue Bridge over Brown's Line in 2019 and 2020, starting in May 2019. This work will ensure that the bridge meets today's standards and remains safe for vehicles and pedestrians into the future. The project is part of the Council-approved 2019 Capital Works Program.

WORK DETAILS

The City's contractor will:

- reconstruct the concrete parapet walls, railings and approach slabs
- repair the concrete deck and sidewalks, the substructure's piers, abutments and retaining walls
- replace bridge bearing, asphalt surface and waterproofing
- Improve bridge approaches and drainage

Phase 1 Brown's Line under Evan's Avenue	May 2019 to December 2019	One northbound or southbound lane will be closed. Two lanes of traffic in each direction will be maintained during peak Monday to Friday traffic flows, from 3 p.m. to 8 p.m.
Phase 2 On Evan's Avenue	April 2020 to September 2020	Single-lane closures eastbound and westbound for work on top of the Evans Avenue bridge will occur. A minimum of two eastbound lanes, as well as a single westbound lane and a dedicated left turn lane onto Brown's Line, will be maintained at all times.
