
Road Resurfacing on Morningside Avenue and Sewells Road

Contract: 18ECS-TI-02MR Start Date: April 29, 2019 End Date: September 6, 2019 *Timeline is subject to change.

The City of Toronto will resurface the road on Morningside Avenue from Cinemart Drive to Sewells Road; and on Sewells Road from Neilson Road to Morningside Avenue. Our inspection of the road shows that it needs resurfacing and sections of damaged curb and sidewalk need to be replaced to bring them to a state of good repair.

This work is part of the Council-approved 2018 Capital Works Program to renew aging city roads and sidewalk for current and future needs.

WORK DETAILS

The City's contractor will:

- Dig up the road surface
- Re-align maintenance holes and catch basins
- Repair curbs, gutters and driveways
- Repave the road surface
