TORONTO LICENSING TRIBUNAL: June 6, 2019 Summary of Decisions E. Montigny / V. Francis / M. Laverty

1. Mohammad Nadeem Iqbal Qureshi (Report No. 7168)

Holder of Vehicle-For-Hire Driver's Licence No. D01-4656235

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on March 5, 2019.

Vehicle-For-Hire Driver's Licence will be subject to the following conditions:

- (1) All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled:
- (2) Vehicle-For-Hire Driver's Licence will be immediately suspended for one (1) day; Mr. Iqbal Qureshi must surrender his licence and photo card to Municipal Licensing and Standards on the first day of the suspension;
- (3) Vehicle-For-Hire Driver's Licence will be placed on probation for a period of two (2) years. - (4) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Iqbal Qureshi or any other concerns with respect to the conduct of the licensee, those matters and report no. 7168 and any updating material, may be brought back before the Tribunal for a full hearing.
