# TORONTO LICENSING TRIBUNAL: June 13, 2019 Summary of Decisions M. Laverty / A. Bakshi / M. Lee

# 1. Estate of Mustafa Negah (Report No. 7259)

Nadia Negah, Estate Trustee Holder of Taxicab Owner's Licence No.: V02-4701240, Taxicab Plate No. 1644

#### **DECISION:**

The Tribunal approved an extension of Taxicab Owner's Licence No. V02-4701240 for Taxicab Plate No. 1644 to remain in the Estate of Mustafa Negah until Monday, November 18, 2019.

The Tribunal ordered that if the licence is not transferred out of the Estate by November 18, 2019, the licence shall terminate, and if so, Ms. Negah is required to surrender the Taxicab Licence and the Plate to Municipal Licensing and Standards.

# 2. Mohamed Awad Ali (Report No. 7164)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-3110081

Additionally, the Tribunal revoked Mohamed Awad Ali's Vehicle-For-Hire Driver's Licence effective today, June 13, 2019.

# 3. Sarbjit Singh Sahota (Report No. 7212)

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B910320)

# **DECISION:**

The Tribunal approved the request for adjournment of this matter to December 5, 2019, on consent. Municipal Licensing and Standards requested an adjournment in order to contact a police witness.

The applicant advised that he is not available to attend a hearing until December 5, due to employment obligations.

### 4. Shahid Ali Khan (Report No. 7071)

Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B836841)

### DECISION:

The Tribunal approved the joint Proposed Resolution signed on June 13, 2019.

Vehicle-For-Hire Driver's Licence will be issued to Mr. Khan, subject to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application may be cancelled;
- (2) Immediately upon being issued, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of four (4) years. Mr. Khan is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Khan and conduct other investigations, as appropriate, to assess Mr. Khan's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Khan or any other concerns with respect to the conduct of the licensee, those matters and report no. 7071 and any updating material, may be brought back before the Tribunal for a full hearing.
