TORONTO LICENSING TRIBUNAL: May 30, 2019 Summary of Decisions M. Lee / E. Montigny

1. Masood Hejran (Report No. 7171)

Applicant for a Tow Truck Driver's Licence (Application No. B859490)

DECISION:

The Tribunal denied Masood Hejran's application for a Tow Truck Driver's Licence.

2. Shahid Ali Khan (Report No. 7071) Applicant for a Vehicle-For-Hire Driver's Licence (Application No. B836841)

DECISION:

The Tribunal adjourned this matter to June 13, 2019.

Mr. Khan contacted the Tribunal Administration office on May 30, 2019 to request an adjournment to the next available date. The parties agreed to June 13, 2019, on consent.

3. Muhammad Hasan (Report No. 7186)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-4806905

DECISION:

The Tribunal approved the joint Proposed Resolution, originally signed on May 6, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of three (3) years. Mr. Hasan is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Hasan and conduct other investigations, as appropriate, to assess Mr. Hasan's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Hasan or any other concerns with respect to the conduct of the licensee, those matters and report No. 7186 and any updating material, may be brought back before the Tribunal for a full hearing.
