# TORONTO LICENSING TRIBUNAL: May 23, 2019 Summary of Decisions M. Carter-Whitney / A. Bakshi / V. Francis

1. Beruk G. Belachew (Report No. 7104)

Applicant for the Renewal of Vehicle-For-Hire Driver's Licence No. D01-3502862

### **DECISION:**

The Tribunal approved the joint Proposed Resolution signed on May 23, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Immediately upon being renewed, Mr. Belachew's Vehicle-For-Hire Driver's Licence will be suspended for a period of twenty one (21) days commencing today. Mr. Belachew must surrender his Vehicle-For-Hire Driver's Licence and his photo card to Municipal Licensing and Standards immediately after this hearing;
- (3) Immediately upon being renewed, Vehicle-For-Hire Driver's Licence will be placed on probation for a period of four (4) years. Mr. Belachew is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Belachew and conduct other investigations, as appropriate, to assess Mr. Belachew's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) Prior to each of the next four (4) renewals of the licence, Mr. Belachew must provide to Municipal Licensing and Standards, at their own expense, an original up-to-date abstract of their Criminal Record and Judicial Matters Check;

- (5) During the probationary period, if Mr. Belachew incurs any alcohol related driver's licence suspension, charges and/or convictions, he must notify Municipal Licensing and Standards, in writing, within 24 hours. The notification shall include his ML&S licence number and the ticket number(s). Mr. Belachew can notify Municipal Licensing and Standards in one of the following ways:
  - in person at 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via regular mail to: 850 Coxwell Ave, Toronto, Ontario M4C 5R1;
  - via email to mlsconditionreporting@toronto.ca; or
  - via fax at 416-392-3102
- (6) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Belachew or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7104 and any updating material, may be brought back before the Tribunal for a full hearing.
- Mustaba Azimi (Report No. 7178) Applicant for a Tow Truck Driver's Licence (Application No. B887722)

## **DECISION:**

The Tribunal deemed Mr. Azimi's application for a Tow Truck Driver's Licence as abandoned.

(Mr. Azimi did not attend today's hearing)

3. Zafar Khan (Report No. 7059) Holder of Vehicle-For-Hire Driver's Licence No. D01-4308954

## DECISION:

The Tribunal approved the joint Proposed Resolution signed on May 23, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subject to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the licence may be cancelled;
- (2) Vehicle-For-Hire Driver's Licence will be placed on probation for a

period of one (1) year. Mr. Khan is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Khan and conduct other investigations, as appropriate, to assess Mr. Khan's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;

- (3) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Khan or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7059 and any updating material, may be brought back before the Tribunal for a full hearing.
- 4. Chaudhry Ali Ijaz Cheema (Report No. 7190) Holder of Vehicle-For-Hire Driver's Licence No. D01-4816244

## **DECISION:**

The Tribunal approved the joint Proposed Resolution, originally signed on May 14, 2019.

Vehicle-For-Hire Driver's Licence will be renewed, subjected to the following conditions;

- All fees, documents and/or any outstanding requirements must be submitted to the satisfaction of Municipal Licensing and Standards within 30 days of the Tribunal hearing, failing which the application/licence may be cancelled;
- (2) Vehicle-For-Hire Driver's Licence will be renewed and immediately suspended for a period of ten (10) days. Mr. Cheema must surrender his licence and photo card to Municipal Licensing and Standards on the first day of the suspension;
- (3) The term of probation that was placed on Vehicle-For-Hire Driver's Licence No. D01-4816244 at the Tribunal Hearing on May 17, 2018, set to expire on May 17, 2020, will be extended for another two (2) years. Mr. Cheema is advised that during the probationary period, MLS may make additional checks of any driving, criminal, and by-law charges and convictions against Mr. Cheema and conduct other investigations, as appropriate, to assess Mr. Cheema's compliance with the requirements of Chapter 546 of the Municipal Code and other applicable laws;
- (4) Conditions No. 3 and 4 previously imposed by the Toronto Licensing Tribunal on May 17, 2018 are to continue throughout the probationary period until May 17, 2022;

(5) During the probationary period, if Municipal Licensing and Standards has concerns with any new charges or convictions against Mr. Cheema or any other concerns with respect to the conduct of the licensee, those matters and Report No. 7190 and any updating material, may be brought back before the Tribunal for a full hearing.
