Hatchford Stormwater Pond

The City of Toronto's Hatchford Stormwater Management Pond is located south of Bridlewood Boulevard and Hatchford Court, north of Sheppard Avenue East, west of Forestbrook Crescent and east of Wicklow Drive. The purpose of the pond is to collect stormwater runoff from roads and sidewalks, which helps to reduce localized flooding and improves water quality. There are numerous stormwater ponds throughout the City and enhanced safety measures like fences and signage are being put in place to ensure people are a safe distance from the water. From time-to-time, the ponds require dredging and cleaning which is why access roads are required. There are also sewer mains located underground in the pond area requiring maintenance access.

In order to accommodate a new condominium development at 3220 Sheppard Avenue East, the City's alternate access road to this stormwater pond is no longer available.

WORK DETAILS




As a result of the condominium development at 3220 Sheppard Avenue East the following work will be undertaken:

- Permanent closure of the alternate access road from Sheppard Ave.
- An existing access road from Hatchford Court needs to be refurbished and extended to maintain both ponds.
- The City-owned stormwater ponds will have a new chain-link fence installed on City property along the entire length of the access road, behind the properties on Forestbrook Crescent.
- To accommodate the access road, naturalized shrubs on City property will need to be removed at the start of construction.

WHAT TO EXPECT DURING CONSTRUCTION

- Residents will experience some inconveniences during this work. The City will make every effort to reduce the impact. We appreciate your patience.

	<p>Work Hours: Work will be completed in accordance with the City's Noise By-law between 7:00 a.m. to 7:00 p.m., Monday to Friday, with occasional work after hours and on weekends if required.</p>
	<p>Trail, Road and Sidewalk Access: Once the access road is closed at 3220 Sheppard Avenue East the access road at 1 Hatchford Court will be used by the City for storm pond maintenance work.</p>
	<p>Shrub Removal: In order to accommodate the new access road to the City's stormwater pond, some naturalized shrubs on City property will need to be removed.</p>
