
Rehabilitating the Crescent Town Pedestrian Bridge

Contract: 19ECS-TI-15BE
Start Date: Early September 2019
End Date: Late June 2020
Winter break: December 2019 – May 2020

*Timeline is subject to change.

The City of Toronto will rehabilitate the Crescent Town Pedestrian Bridge. This work will ensure that the bridge meets today's standards and remains safe for pedestrians into the future. This project is part of the Council-approved 2019 Capital Works Program to bring infrastructure to a good state of repair.

WORK DETAILS

The City's contractor will:

- Repair and refurbish the existing Crescent Town Pedestrian bridge
- Install louver panels between the windows and columns to prevent rain from entering the bridge
- Replace roofing
- Install a non-slip floor sealant

Construction will take place in two stages:

Construction will take place in two stages.		
Phase/Location	Dates	Traffic Management / Bridge Closures
Stage 1 Interior and piers	September 2019 to December 2019	The left lanes northbound and southbound on Victoria Park Avenue will be closed during Stage 1 of the project schedule. One lane will remain open in each direction. The bridge will be closed to pedestrians between 11 p.m. and 7 a.m. on 10 to 12 occasions between October and December 2019. Notices will be posted on the bridge before the closures.
Stage 2 Southwest corner and roof	May 2020 to June 2020	Work on the southwest corner and roof of the bridge will not affect traffic.

WHAT TO EXPECT DURING CONSTRUCTION

 You may experience dust, noise and other inconveniences. The City will make efforts to reduce impacts. We appreciate your patience.



Work Hours: Work will take place from 7 a.m.to 7 p.m., Monday to Friday, with work after hours and on weekends as required.

Overnight Work: There will be 10 to 12 twelve overnight work shifts between 11 p.m. and 7 a.m. as approved by the City. Notice will be provided.



Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times. Sidewalks will remain accessible.

Pedestrian Bridge: The bridge will remain open at all times with the exception of 10 to 12 overnight closures during Stage 1 between the hours of 11 p.m. and 7 a.m.

Work within the bridge will be performed behind protective hoarding. During this work, the barrier-free path of travel width of the bridge will be reduced to 1.4m beside the work zone.



Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.



Accessible Accommodation: Residents who require accommodation (longer notice, etc.) must contact the **Project Manager** to arrange for access during the construction period.



Restoration: Areas affected by construction will be restored.
