Basement Flooding Protection Program on Glenwood Crescent

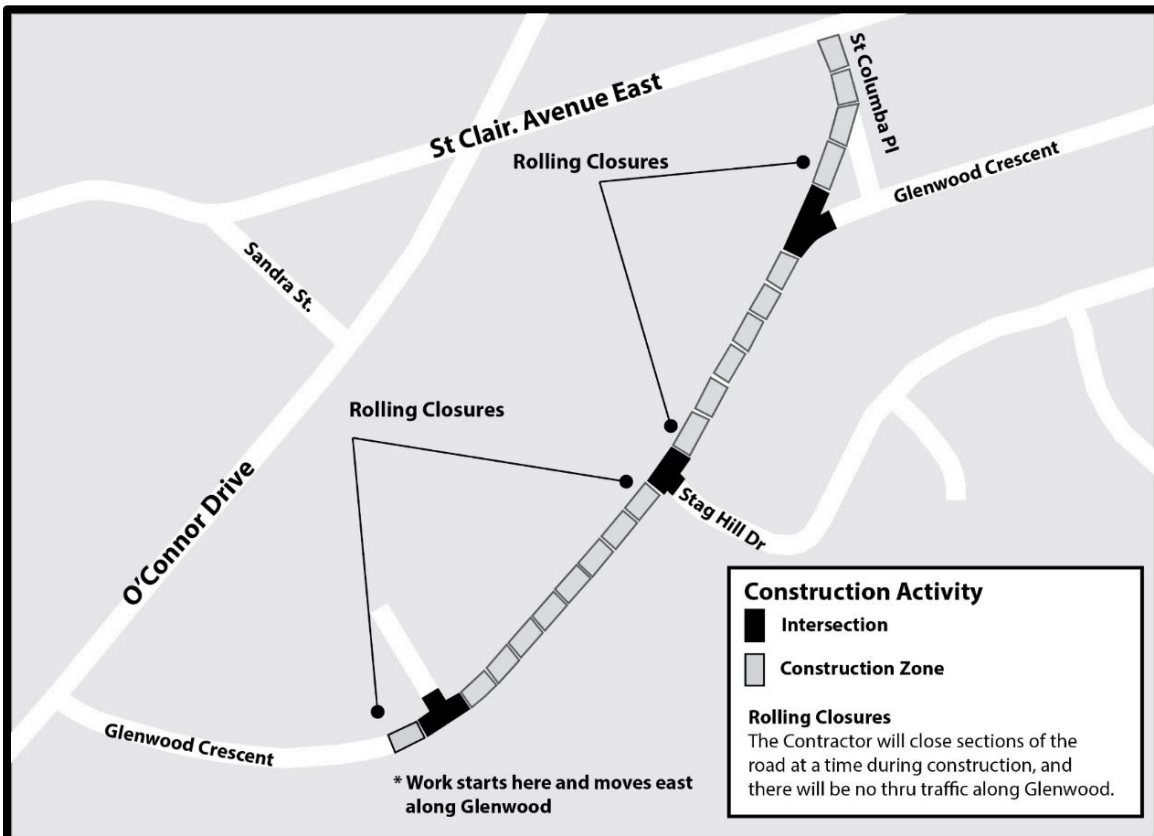
The sewer upgrades on Glenwood Crescent between Glen Gannon Drive and Rexleigh Drive are complete, and our contractor will be replacing substandard water services in this area in the coming weeks. The road will be restored shortly and all lanes will be open.

The City's contractor will begin construction of a box culvert sewer starting the week of August 12. Traffic will be reduced to one lane in the area around Glenwood Crescent and Glenwood Terrace for work taking place in the boulevard and ravine.

Starting the week of August 19, rolling closures along Glenwood Crescent will begin as work gets underway for construction of the box culvert sewer. The work will start near the intersection of Glenwood Crescent and Glenwood Terrace and will require rolling closures, moving eastward along Glenwood Crescent until December 2020. **There will be NO through traffic on Glenwood Crescent from late August 2019 to December 2020 because the box culvert sewer installation requires the entire width of the road. Residents on Glenwood Crescent from Glenwood Terrace to St. Columba Place will receive further notice from the City regarding alternate parking arrangements when this work affects driveway access. **Residents who have not provided their license plate information to the City should contact the Public Consultation Unit, details on page 2.**

WHAT TO EXPECT DURING CONSTRUCTION

You may continue to experience dust, noise and other inconveniences. The City will make efforts to reduce the impacts. We appreciate your patience.

	<p>Work Hours: Work will take place from 7 a.m. to 7 p.m. Monday to Friday, with work after hours and on weekend as required.</p>
	<p>Watermain By-Pass: During construction, there will be a temporary watermain bypass system in place. The by-pass piping will be connected to the outside tap of your home. Please ensure that your outside tap is kept turned on at all times to ensure water supply to your home during construction. It is safe to drive your vehicle over the ramped temporary watermain pipe on your driveway.</p>
	<p>Road and Sidewalk Access: In order to complete the work in a safe manner, there will be road and sidewalk restrictions within the construction work zone. Access for emergency vehicles will be maintained at all times.</p> <p>Driveway Access: Due to the nature of the work, there will be temporary periods of time where it is not feasible to maintain access to driveways. The contractor will notify you of any temporary restrictions to your driveway access. If your driveway access will be restricted beyond work hours, the contractor will notify you in advance and alternative parking arrangements will be made.</p>
	<p>Traffic Management: Efforts have been made to manage traffic in the area for the safety of workers, road users and residents. Road users should expect delays and increased traffic on nearby main and side streets.</p> <p>During construction, Glenwood Crescent will be closed to through traffic. Only Local Access will be permitted.</p>
	<p>Parking: Parking in the active work zone is not permitted due to space requirements for construction equipment and materials. If your parked vehicle affects the construction work, it will be re-located with no charge to the owner. If your vehicle is moved, please contact parking control for its location at 416-808-2222.</p> <p>Specific details regarding parking for affected properties will be provided by the contractor 48 hours prior to the work starting in front of your property.</p> <p>In the event you receive a traffic ticket for on-street parking during this period of construction, you may choose to dispute your ticket following the process listed on the reverse side of the parking infraction notice.</p> <p><i>You may use this notice as part of your defense for parking consideration during construction; however, the Field Ambassador does not have the authority to cancel any parking tickets.</i></p>
